On June 19, Cochecho Waterfront Development Advisory Committee voted to select Cathartes of Boston as the preferred developer for the waterfront redevelopment project. This decision was the culmination of an extensive review process that involved submission of firm qualifications (RFQ) and subsequently a full proposal for design and development.

Originally six companies were interviewed by CWDAC in January after each had responded to an RFQ in late 2017. Three companies were selected to move to the final proposal (RFP) stage. After one of the companies withdrew, proposals were submitted on May 24 by Summit Land Development and Cathartes. The full membership of CWDAC held thorough interviews with each company and their representatives on June 6. Upon review of the final proposals and the face-to-face interviews, the Committee unanimously agreed that Cathartes was the most qualified candidate.

Cathartes is proposing a mixed use development that includes:


- 256 residential units;
- 53 town house units;
- hotel;
- 4,000 square-foot restaurant, and;
- over 500 parking spaces.



Its proposed development design is very similar to the site layout plan prepared by CWDAC with the assistance of Union Studios as shown on the rendering above. According to Committee Chair, Dana Lynch, "Cathartes not only proposed a plan that was consistent with the City's vision, the firm also understood the important connection of the future development to the rest of downtown Dover." ## CWDAC Mission Statement

"... [T]o provide a vibrant waterfront with public gathering places and access to the water, a place for people to live, meet, relax, encounter nature, conduct business and learn of Dover's past."



Cathartes is the developer for the mixed-use project currently under construction, known as 104 Washington Street, which is located on the site known as the Robbins block in downtown Dover. The firm also developed the prize-winning Portwalk Place in downtown Portsmouth, a 400,000 square-foot, mixed-use development.

Currently the city and CWDAC are negotiating with Cathartes to prepare a term sheet that will detail the terms of an agreement for the development.



## Paddle sports dock now in place

As part of the development of a waterfront park along the riverfront area, a public paddle sports was constructed and opened to the public on June 1. The dock is designed to accommodate a range of vessels from single canoes and kayaks to large crew boats. It is fully compliant with American with Disabilities Act accessibility standards.

After conducting a competitive bid process, the City Council voted in December 2017 to award the bid for construction and installation of the dock to a Vermont company - The Dock Doctors. The City Council also approved acceptance of a generous donation of \$19,000 from the Great Bay Rowing Club to help pay for the dock.

According to Gary Bannon, Dover's Recreation Director, "The new paddle sports dock is a tremendous asset to the City and downtown Dover. It's been very popular and is being used by many residents and visitors."
