Chief Anthony F. Colarusso, Jr. of the Dover Police Department announces the arrest of eleven individuals for various drug related offenses within the city.

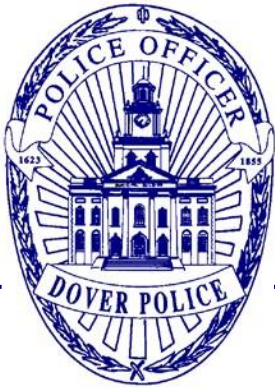
The arrests were the result of a two month long drug investigation conducted by members of the Dover Police Department's Community Response and Enforcement Unit in partnership with the United States Drug Enforcement Administration.

"While we need to work hard to prevent and treat drug abuse, we also have to vigorously enforce our laws. Bringing many law enforcement assets together is an effective way to do this", Chief Colarusso said.

Those arrested include the following:

Richard M. Folger, 31, of 27 Liberty Circle Milton, NH, was charged with felony possession of controlled drug, heroin. Folger was arrested on September 8, 2016 at 7:07PM. He was released on \$1500 personal recognizance bail and was scheduled to appear for arraignment in Strafford County Superior Court on September 26, 2016. His bail remains \$1500 personal recognizance.

Isaiah N. Johnson, 36, of 1 Flanders Court Dover, was charged with felony possession of controlled drug, crack cocaine, and felon in possession of dangerous weapon, a large knife with a curved blade and metal spikes. Johnson was arrested on September 20, 2016 at 1:38PM and waived the services of a bail commissioner. He was arraigned on September 21, 2016

in Strafford County Superior Court and released on \$2500 cash or surety bond.

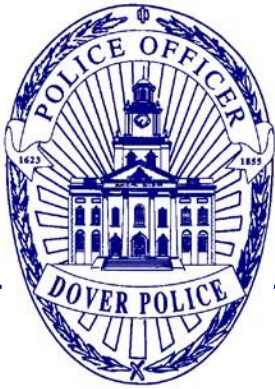

She is scheduled to appear for arraignment in the 7<sup>th</sup> Circuit District Division Dover on February 27, 2017 at 8:00AM.

Glenn Y. Smith, 30, of 41 Belknap Street apartment 1 Dover, was charged with felony possession of controlled drug, heroin, and electronic bench warrant, misdemeanor. Smith was arrested on October 27, 2016 at 9:00PM and arraigned in Strafford County Superior Court the following morning where he was released on \$5000.00 personal recognizance bail.

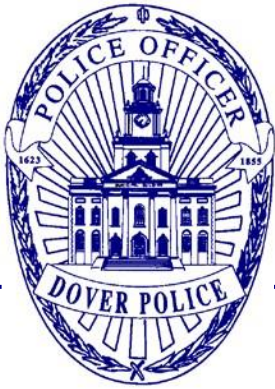

Pitts is scheduled to appear for arraignment in Strafford County Superior Court on November 29, 2016 at 9:00AM.
