Coming up at the next City Council meeting

### City Council to discuss, consider vote on proposed CIP

The City Council will discuss the fiscal year 2022-2027 Capital Improvements Program (CIP) at its meeting this Wednesday, Nov. 18, and possibly vote to authorize the three sections of the CIP. The Council is also scheduled to hold a workshop on the CIP in the hour before its regular meeting.

The CIP is a city-wide planning effort that begins the fiscal year's budget cycle, starting on July 1, 2021. Projects included in the plan are capital projects and purchases over \$25,000 that maintain and improve the community infrastructure and have a useful life of at least three years. The CIP six-year program links infrastructure spending to the City's Master Plan's goals and values.

For fiscal year 2022 that begins on July 1, 2021, the CIP has \$18,244,036 in proposed capital projects. That includes

\$8,003,036 funded through the operating budget, \$6,696,000 funded through debt-financing, and \$3,545,000 funded from reserve accounts.

The CIP is updated annually and involves input sessions with the Planning Board and City Council, including public hearings for both boards. The Planning Board began its CIP discussions at its [Oct. 13 meeting](#) that included a public hearing; it voted to approve the CIP at its [Oct. 27 meeting](#). The Planning Board reviews the CIP to see if it meets the needs expressed in the City's Master Plan. The City Council held public hearings related to the CIP at its [Oct. 28 meeting](#).

As City Manager J. Michael Joyal, Jr. explained at the joint City Council and Planning Board CIP workshop Oct. 7, to approve the CIP entails voting on three resolutions: the plan itself, debt-service projects, and non-debt projects that are not funded by the City's general fund.

The vote on adopting the plan "is a statement of intent, but it does not bind you to anything," Joyal said at the [Oct. 7 workshop](#). "It tells me as your City Manager and anyone else in the City, this is your long-term plan on how things are going to happen in the City for upgrading roads, infrastructure, replacing equipment and so forth. From an operational perspective, it allows us to start making plans or continuing plans for replacing equipment, and perhaps not investing in maintenance in certain things because we know we will replace it in a timely fashion."

The vote on debt-service projects is only for the year-one CIP projects approved by the City Council. The vote on the CIP's non-debt portion is for year-one CIP projects funded by capital reserves accounts and grant funds. These two votes require a two-thirds majority to pass.

## Public hearing on establishing a process for review and final proposal of potential charter amendments

The City Council is also scheduled to hold a public hearing on "establishing a schedule and process for review and final proposal of potential charter amendments."

According to the resolution, during the recodification of the City of Dover's codes, "several provisions of the City's charter were identified as potentially in need of amendment." Many of the potential amendments provided in the background are formatting, style and/or typographical errors.

After the public hearing, the Council is expected to direct the Council's Ordinance Committee to "study and review potential amendments" and report back to the council by May 12, 2021. The Council may then decide to begin a formal charter amendment process that could bring charter amendment questions to the municipal election planned for Tuesday, Nov. 2, 2021.

The Wednesday, Nov. 18 regular meeting of the Dover City

Council is scheduled to begin at 7 p.m. in the Council Conference Room at City Hall. The CIP workshop will be held in the same location beginning at 6 p.m. The meetings are open to the public. Meetings can be watched live on Channel 22 or online at <https://dovernh.viebit.com/index.php>.

## Dover Veterans Park adds 15 new bricks ahead of Veterans Day

The latest batch of engraved bricks honoring veterans was installed Monday at Dover Veterans Park in time for Wednesday's Veterans Day ceremony.

The Dover Veterans Park was dedicated three years ago on Veterans Day 2017. The 15 new bricks added Monday brings the total number of bricks honoring veterans to about 800, said Recreation Director Gary Bannon. He said there is still plenty of capacity to add bricks to honor veterans, emphasizing the veterans do not need to be from Dover to be included in the park.

"It's for veterans," said Bannon of the park. "If you served in the military, you've qualified in

being a veteran.”

Many of the bricks honoring veterans have been grouped by family or by service time. A few bricks already installed were moved Monday so they could be grouped with others. “It’s a nice statement of camaraderie and unity,” Bannon said.

Next spring, city workers will install a bench donated by the Class of 1965 at St. Thomas Aquinas High School. A new kiosk that lists and maps all veterans-related monuments and plaques in Dover is also planned. “There are more than 1,000 names on all of those plaques,” said Recreation Director Gary Bannon, who has overseen the creation and upkeep of Dover Veterans Park.

Bricks are not added on a rolling basis. Instead, Bannon places two orders a year: one ahead of Memorial Day and the other ahead of Veterans Day. Because the production takes about two months, Bannon placed the Veterans Day order at the end of August, and the new bricks just arrived last week. He’ll make the next order at the end of February 2021 to be ready for Memorial Day in May.

The cost is \$100 for an 8-inch by 8-inch brick and \$50 for a 4-inch by 8-inch brick. All bricks are engraved consistently with a full name, military rank and branch, and years of service and/or conflict.

## Community Action Partnership of Strafford County opens emergency winter shelter

### Dover, Tri-cities, Strafford County and others contribute funding

Community Action Partnership of Strafford County (CAPSC) will open an emergency winter shelter to homeless clients at the Garrison Hotel in Dover starting this Monday, Nov. 16. The shelter will remain open until Thursday, April 15, 2021.

The winter shelter will not be an emergency cold weather shelter as initially planned, Dover City Manager J. Michael Joyal, Jr., told the City Council at its Oct. 14 meeting. Instead, the Garrison Hotel will supplement regional homeless shelters that have reduced capacity due to the COVID-19 pandemic.

The City Council approved a resolution authorizing the City to contribute up to \$40,000 as its share to help fund the 24-hour CAPSC-staffed shelter at the Garrison Hotel. The cities of Somersworth and Rochester are also contributing funding along with Strafford County, the New Hampshire Housing Finance Authority, Community Development Finance Authority, and the Department of Health and Human Services’ Bureau of Housing.

Clients must be referred to the shelter from area partners, such as municipal welfare offices, police and fire departments, 211, other area shelters, and/or medical and social service providers.

“With the challenges of COVID-19, the previous emergency shelter models were not sustainable or safe this winter season, said CAPSC CEO Betsey Andrews Parker. “We learned from previous cold-weather seasons that we needed longer and more consistent shelter operations to help clients stay safe from both COVID and the cold.”

In addition to rooms with COVID-safe protocols, housing insecure individuals and families can access additional support services at CAPSC’s main office at Bradley Commons, 577 Central Avenue in Dover. Clients using the shelter and expanded housing programs will also have access to communication resources, primarily for telehealth appointments with medical and mental healthcare providers, social services, or employment resources. Additional access to medical care and substance misuse support is available through partnerships with Goodwin Community Health, SOS Recovery Community Organization, The Doorway operated by Wentworth-Douglass Hospital, Tri-City Co-op, Seacoast Mental Health Center, and Community Partners.

“While these services exist in our community already, COVID-19, as well as the other challenges of being homeless, prevent many clients from accessing these services or keeping appointments,” said Lauren Berman, Director of Housing and Economic Support at CAPSC. “When people have a warm place to sleep and feel safe, it allows them to begin the process of planning for future next steps.”

CAPSC is seeking additional community support through volunteers to help with reception, manage donations, and provide clients. Volunteers will need to complete an interview and background check to work with clients. Those interested should contact Berman at [lberman@straffordcap.org](mailto:lberman@straffordcap.org).

Volunteer support is also needed on weekends to serve dinner to 30-40 individuals. Meals will be prepared off-site and delivered to the Garrison Hotel.



## 'extreme' drought

There was no change in New Hampshire's ongoing drought conditions in this week's U.S. Drought Monitor [update](#) released Thursday. Sections of southern Dover are in "severe" drought, while the rest of the City and much of Strafford County remain in "extreme" drought.

The City of Dover's mandatory outdoor water restrictions remain in effect. Those restrictions include

- No outside lawn watering or irrigation, including automatic sprinklers, automatic irrigation systems, and no unattended lawn watering
- No washing of vehicles, including automobiles, trailers and trucks
- No filling of swimming pools greater than 100 gallons
- Hand watering of gardens and new plantings is allowed.

City officials still urge residents and businesses to continue to voluntarily conserve water in other ways, such as cutting back on shower times, only doing full loads of laundry when necessary, and turning off the faucet while brushing teeth, doing dishes and washing hands. Fixing leaks, including running toilets, can reduce individual usage by hundreds of gallons a day.

### State emergency drought assistance available to low-income residential well owners

The NH Drinking Water and Groundwater Advisory Commission and the NH Dept. of Environmental Services (NHDES) have created a new initiative to provide short-term relief and financial assistance for low-income homeowners served by residential wells that are experiencing insufficient water or no water due to drought conditions.

The initiative will include temporary relief to ensure households have an adequate supply of drinking water in the near-term. Households on residential wells, whose income is at or below 80 percent of the area median household income and have no water due to the ongoing drought, may be eligible for bottled water deliveries at no cost for drinking and cooking uses. The provision of bottled water is intended to be a temporary measure until the

### **Permanent drought relief measures**

Financial assistance for improving or replacing residential wells with insufficient water due to drought, or connection to an existing community water system, financial assistance may be made available for qualifying low-income homeowners through a grant from the NH Drinking Water and Groundwater Trust Fund.

Assistant City Manager/Director of Strategic Initiatives Christopher G. Parker said if signs aren't removed by the following Monday, Nov. 16, staff contacts the candidates to remind them to remove them. ## Strand's upcoming telethon part of fundraising effort to keep venue open in 2021

The non-profit Strand Theatre on Third Street in downtown Dover will host a virtual telethon next Friday, Nov. 20, from 6 p.m. to midnight to fundraise for the 2021 season.

The telethon is pre-recorded, and those who wish can make donations by either purchasing tickets or donating to The Strand's GoFundMe campaign. The telethon will include performances by local artists, film features, vaudeville acts, and more. Terry Traynor, owner of New Hampshire-based Narrow Street Films, is the telethon's producer. The event will be streamed on Facebook and other mediums.

The Strand has fundraising gifts, said Dan Demers, chair of the Strand Ballroom Corporation's board of directors. Those who donate \$50 or more will receive a pair of tickets to a Strand performance in the 2021 season. Those who donate \$100 or more will receive a limited-edition, 11-inch by 14-inch individually signed painting of The Strand by The Art Center's Resident Artist Deborah Janelle.

The Strand Theatre has a goal to raise \$100,000 by Dec. 31, 2020, to continue operations. The theater, which has collaborated with the City of Dover's Office of Economic Development in the past, had an in-person fundraiser planned for this Saturday, Nov. 14. But Demers said the board decided to postpone the event because of the rise in Dover's positive Coronavirus cases.

Demers said theater shows next year are in danger if the non-profit can't raise enough money to cover costs. Demers said he has been funding any operational deficits with his retirement savings, "which is almost gone."


Demers said before COVID hit, the board had high hopes for 2020. "This year was projected to be a positive year," he said. "We broke even last year. (2020) was to be the start of a new era."

The Strand closed in March when Gov. Chris Sununu ordered all nonessential businesses closed. It reopened on July 1 with limited capacity. The Strand, which celebrated its 100th anniversary in Sept. 2019, has put on two theater shows since its July reopening: "Bless Me Father" and "Dracula." It has also hosted comedy nights and open-stage events and rented out the hall for private events. Demers said The Strand hasn't held concerts because people will want to get-up in dance.

Out of its 280 seats, Demers said The Strand could seat a max of 88 people if all were to come in groups of five, with three empty seats on either side of a party. It has eliminated its VIP seating because it's too close to the performers, Demers said.

Demers opened The Strand Theatre on Apple Harvest Day in 2015 as a for-profit company. The entity became a not for profit corporation in 2017.


**Nov. 15, 1697** — Thomas Chesley and Will Jackson are captured not far from Johnson's Creek. Chesley is slain but Jackson escapes.

**Nov. 17, 1707** — At a public town meeting at the meeting house on Dover Neck, Capt. John Gerrish, moderator, it was voted that Mr. Pike have 15 pound per annum added to his salary of 65 pounds, one third part thereof to be paid in money, the other two thirds in provision as formerly, and that the mill rents as they shall be received be a part of his salary.

**Nov. 18, 1755** — "About four o'clock in the morning was an exceeding shock of ye earthquake which shock was near as much as that in ye year 1727, Oct. 29, but ye noise was not so loud." (diary entry) John Winthrop Hollis, Professor of Mathematics and Philosophy at Harvard College, described the "great earthquake which so lately (Tuesday, Nov. 18, 1755) spread terror and threatened desolation throughout New England," in a lecture delivered in the chapel of the college on the week following the earthquake.

**Nov. 13, 1833** — A meteoric shower of stars observable between 3 and 4 o'clock in the morning attracted much attention in Dover and throughout the country.

**Nov. 19, 1856** — Two young men, George S. Clark, aged 26, and John Foss, aged 23, were killed by the premature discharge of a cannon which they were firing on Garrison Hill to celebrate the election of President Buchanan.

## Dover Varsity Cheer crowned state champions

Dover Varsity Cheerleading (DVC) was crowned Division 1 Fall Spirit New Hampshire Interscholastic Athletic Association ("NHIAA") 2020 State Champions with a score of 102.7. Runner up, Concord Varsity Cheer, earned a score of 97.6.

In a season gripped by the COVID19 pandemic, Dover was fortunate to have any season at all. To mitigate crowd concerns, all competitions were virtually held which meant teams had to film their routines with Athletic Director affidavit and in most cases with no spectators at all.

Dover went undefeated in an abbreviated season which kicked off with the 603 Showdown hosted by Londonderry High School Cheerleading and concluded with the Battle at the Capitol hosted by Concord Varsity Cheer where Dover won their respective division and was named overall Grand Champion with the highest scoring routine of the day.

DVC is led by Head Coach Kelsey Daigle and supported by Assistant Coach Mikaela Leighton. The team did not start practicing until September 8, with mere weeks before its first competition the athletes had a great deal of work to do. The team learned a very advanced routine, packed



with tons of difficulty, only weeks before having to compete it. During a normal season, the team has months to prepare. "I am so incredibly proud of what this team has done and overcome this season," said Daigle. "They amaze me and I am grateful to be their coach!"



## How cloth face coverings help slow the spread of COVID-19

COVID-19 spreads mainly from person to person through respiratory droplets produced when an infected person coughs, sneezes, talks, or raises their voice (e.g., while shouting, chanting, or singing). These droplets can land in the mouths or noses of people who are nearby or possibly be inhaled into the lungs. Studies show that a significant portion of individuals with COVID-19 lack symptoms (are "asymptomatic") and that even those who eventually develop symptoms (are "pre-symptomatic") can transmit the virus to others before showing symptoms.

To reduce the spread of COVID-19, CDC recommends that people wear cloth face coverings in public settings when around people outside of their household, especially when other physical distancing measures are difficult to maintain.



The City Council unanimously adopted a resolution requesting the use of face coverings in public to help prevent the spread of the COVID-19 coronavirus.

## Why it is important to wear a cloth face covering

Cloth face coverings may help prevent people who have COVID-19 from spreading the virus to others. Wearing a cloth face covering will help protect people around you, including those at higher risk of severe illness from COVID-19 and workers who frequently come into close contact with other people (e.g., in stores and restaurants). Cloth face coverings are most likely to reduce the spread of COVID-19 when they are widely used by people in public settings. The spread of COVID-19 can be reduced when cloth face coverings are used along with other preventive measures, including social distancing, frequent handwashing, and cleaning and disinfecting frequently touched surfaces.

The cloth face coverings recommended here are not surgical masks or respirators. Currently, those are critical supplies that should be reserved for healthcare workers and other first responders. Cloth face coverings are not personal protective equipment (PPE). They are not appropriate substitutes for PPE such as respirators (like N95 respirators) or medical facemasks (like surgical masks) in workplaces where respirators or facemasks are recommended or required to protect the wearer.
