


The City Council will hold a regular meeting on Wednesday, July 22, 2020, beginning at 7 p.m., in the Council Conference Room at City Hall.

The Library is open with the following restrictions:

- The hours of 9 to 10 a.m. will be reserved for elderly or medically vulnerable patrons.
- Patrons with any symptoms of COVID-19, including fever or cough, should not enter the building.
- The Library is requesting that all patrons wear masks. Masks will be provided to those who need one.
- A maximum of 22 patrons will be allowed in the building at a time and of those 22, eight will be allowed in the Children's Room.
- The parking lot door, near the Children's Room, is the designated entrance, and the front door will be the exit. This does not apply to patrons in need of the elevator, or families exiting the Children's Room.
- Patrons will be allotted one hour to be in the building to give computer users enough time to get their work completed. However, patrons are asked to keep their visits as short as possible.
- Please follow all social distancing protocols. Decals on the floor denote 6-foot spacing at service desks.
- Please no food and drink in the building due to the fact that patrons would need to remove their masks to consume.
- Please return all materials in our outside book drops. All books will be quarantined for three days and will be checked in on the fourth day.
- Hand sanitizer will be available at all service desks.
- The DVD collection has been relocated to the Lecture Hall to allow for more spacious browsing.

Outdoor pool to open for recreational swimming on July 20


Jenny Thompson Outdoor Pool

Locker room use will be limited.

- Capacity will be limited to 40 patrons on a first come, first served basis.
- Patrons must maintain 6 feet of physical distance from other patrons who are not members of the same household.
- Masks must be worn when entering and exiting the facility, in the pool lobby, locker rooms and pool deck, prior to entering the water.
- The pool is modified for physical distancing and no equipment, such as goggles, will be provided.
- The use of any equipment, including kickboards, fins, noodles, toys, and barbells are not allowed until further notice.
- Diving boards will be open to the public from 1:30 to 2:30 p.m. and 3 to 3:30 p.m. only.

Under the new guidelines, the Outdoor Pool cannot offer group and private lessons until further notice.

The Jenny Thompson Pool is currently open by reservation only. To reserve a time or to see the pool schedule, visit <https://go.usa.gov/xfxGd>. Patrons must exit the facility no more than 15 minutes after their reserved block has ended.

The pool is not heated at this time. Those using the pool are asked to arrive showered and ready to swim.

McConnell Center

The Fitness Center, located at the McConnell Center, is open during regular hours, Monday through Friday, 7 a.m. to 9 p.m., and Saturday and Sunday, 9 a.m. to 4 p.m.



Precautions will be in place for those using the facility, including:

- The Fitness Center will operate at half capacity
- Staff will be wearing masks and visitors are strongly encouraged to wear masks in all common areas
- Cardio rooms will be limited to 4 people at a time
- Time restrictions may be placed on cardio equipment, if needed
- The weight room, Cybex room and dance studio will be limited to 7 people at a time
- It is recommended that patrons call about room availability in advance to working out
- Additional hand sanitizers will be available
- Anyone who is sick or exhibiting symptoms of COVID-

Butterfield Gym

The Butterfield Gym is open during regular hours.

Dover Community Senior Center

The Dover Community Senior Center, also located at the McConnell Center, remains closed.

Ice Arena

The Dover Ice Arena is open. Although open, a number of Arena programs planned for the summer will not occur, including Learn to Skate, Rock Night, youth and adult introduction to hockey, recreational public skate, and skate rentals from the Pro Shop.

Parks and playgrounds

Some recreation areas are open again to the public, including the Longhill Park Dog Park, pickleball and tennis courts, and the Bellamy Park Disc Golf Course. Several restrictions are and remain in place at these locations until further notice, including prohibited use by those who exhibit and symptoms of the coronavirus, have been in contact with someone with COVID-19 in the last 14 days, or are at risk due to known factors including underlying health conditions.

Pickleball and tennis courts are now available first come, first served. Additional pickleball programs, drop-in and recreational play are also now available.

Parks and playgrounds are no longer closed, but an advisory is in effect. Please remember:

- Playground equipment is not sanitized
- Stay home if you are sick
- Wash hands before and after use
- Avoid touching surfaces
- Use of parks and playgrounds is at your own risk

Dover Indoor Pool

The Indoor Pool is open for lap swim only. Lap swimming will be broken down into one-hour swim blocks, followed by a 30-minute block for staff to clean the facility. Patrons will exit the facility no more than 15 minutes after their swim block has ended.

City Hall

City Hall is open to the public during regular business hours, Monday through Thursday, 8:30 a.m. to 5:30 p.m. and Friday, 8:30 a.m. to 4 p.m.



When open, additional safety precautions and guidelines will be followed at City Hall, including:

- The building is open with limited capacity.
- All staff wear masks. Customers are strongly encouraged to wear a mask. Masks are available to the public, if needed.
- Clear partitions are installed in all offices at City Hall to limit in-person contact.
- While in the building, please remain 6 feet apart from others.
- Hand sanitizing stations are available throughout City Hall.
- All common surfaces are cleaned and disinfected frequently.

Payment for a variety of bills and services can still be made via a drop box at City Hall. The drop box is conveniently located inside the Locust Street Customer Service Center entrance at City Hall and is accessible during regular business hours. Payments for water and utility bills, property taxes and parking violations can be made via the drop box. The drop box can also be used for motor vehicle registrations.

Public School Offices and SAU

School and SAU offices opened to the public on Monday, July 13, by appointment. To make an appointment, call the respective school's main phone line or SAU office. All visitors are required to fill out a questionnaire, have their temperature taken before entering, and wear a mask.

Community Services

The Community Services facility on Mast Road is open to the public during regular hours, 8 a.m. to 4 p.m., Monday through Friday.



The Recycling Center on Mast Road has remained open during its regular schedule of Tuesday, Thursday and Saturday, 8:30 a.m. to 3:30 p.m.

The Wastewater Treatment Facility on Middle Road is open to septic, RV and sludge deliveries.

The chapel at Pine Hill Cemetery is open but appointments are encouraged. To contact the chapel for an appointment, call (603) 516-6480.

Public Welfare

Public Welfare, located at the McConnell Center, is open. Please use Door 3 at the McConnell Center. Public Welfare can also be accessed by appointment. Contact the office by phone at 516-6500 to set up an appointment. Interviews may also be conducted over the phone, instead of in person. Necessary paperwork can be mailed to the office at Dover Public Welfare, 61 Locust St., Dover, NH 03820, faxed to the office or placed under the office door.

Those eligible for welfare benefits must still qualify financially and apply to other programs for which they are eligible.

Public Meetings

Most public boards, commissions and committees are now meeting in person. Provisions are in place to accommodate physical distancing by public body members and the public, including additional audio and visual equipment and overflow space.

Elections

Due to the COVID-19 coronavirus pandemic, the Secretary of State's office has made provisions for all voters to register to vote by mail and to request absentee ballots for any reason.

Under new guidance, voters can now register by mail during the COVID-19 pandemic and can request an absentee voter packet from the City Clerk's Office or from the New Hampshire Secretary of State. Voters need to fill out a

registration form and provide election officials with a copy of a current photo ID, as well as a copy of a bill, bank statement or other document with a name and address.



Voters also need a witness, who will be allowed to stand 6 feet away or behind a window, to watch the voter sign their form and to attest by affidavit to the voter's identity.

Forms must be returned by mail or in person to the City Clerk's office.



Bridge work begins Sunday, will require five-day closing of Route 4 and traffic detours

The New Hampshire Department of Transportation (NHDOT) announces an upcoming five-day closure of US Route 4 in Durham to facilitate the replacement of the Bunker Creek Bridge.

Beginning Sunday, July 19, 2020 at 11 p.m. and lasting approximately five days, US Route 4 will be closed to all through traffic. This phase of work will include demolition of the existing bridge; installation of new precast bridge elements, including the bridge abutments and superstructure; final placement of lightweight fill and roadway materials; and paving.

During the closure, traffic will be detoured from US Route 4 and the Spaulding Turnpike via NH 108 or NH 155 with the use of detour signs and message boards. Trucks are encouraged to use the NH 155 detour. All motorists are encouraged to remain alert and obey all posted signs.

The NHDOT worked closely with local authorities in Dover and Durham to develop a traffic detour plan. The official detour route will be via the Spaulding Turnpike, Exit 7, and NH Route 108 and will be marked with signs. The Dover Police Department is prepared to have officers helping facilitate traffic control at the Exit 7 interchanges during morning and evening peak commute times. The Dover Police Department is also well aware that the closure will result in increased traffic on Piscataqua Road, Back River Road, and Spruce Lane, and will perform extra patrols in these areas to monitor speed and truck restrictions.

The Town of Durham has planned for the geographic challenges associated with the bridge closure, which effectively isolates a small portion of Durham east of the Bunker Creek Bridge. The Dover Police Department and the Newington Fire Department will assist Durham public safety officials through the activation of their mutual aid agreements

to ensure that emergency response times to these Durham properties does not suffer.

The existing bridge was built in 1933 and repaired in 1970. The new bridge will correct two geometric deficiencies, will be higher to accommodate 100-year flooding concerns, and will be constructed to meet today's standards for design, safety and resilience.

US Route 4 is a critical east-west route in NH which carries 16,000 vehicles per day and crosses several environmentally sensitive areas. The new Bunker Creek bridge is designed to last longer and protect this tributary of the tidal Oyster River. The new bridge will be wider to accommodate bicyclists and pedestrians, and will be higher for continued access to safe waterway recreation opportunities in the area.

This work is part of the Durham 16236 Design-Build Bunker Creek Bridge Replacement Project. SPS New England, Inc. of Salisbury, Massachusetts is the Design-Builder for the \$7.1 million project, which is scheduled to be completed in October 2020.

Information session on Lower Central Avenue Redesign Project is July 20

The City of Dover, as part of the ongoing Capital Improvements Program, will redesign Lower Central Avenue between Silver Street and Stark Avenue, including replacing the existing 150-year-old water line, reconstructing the outdated drainage collection and conveyance system, as well as updating streets and sidewalks.

While a construction schedule has not yet been finalized, construction is expected to begin as soon as the spring of 2021. To assist with the project's design work, the City of Dover has engaged Sebago Technics, Inc., a consulting firm involved with Dover transportation initiatives for many years. As part of Sebago's work, the City will explore design alternatives, including additional on-street parking, updating bus stop locations, bike lanes, traffic-calming measures, sidewalk improvements, visual amenities such as landscaping, wayfinding signage and lighting.

Before work begins, the City intends to meet with abutters and residents for input on the project.

An initial listening session will be held on Monday, July 20, at 6 p.m. For the safety of all during the ongoing COVID-19 pandemic, the meeting will be held virtually. Login information will be available here soon.

Dover Arts Commission awards two City Arts Grants

The Dover Arts Commission is pleased to announce the selection of Marielle Carpentier and the Dover Art Center as the recipients of its summer 2020 City Arts Grants. City Arts Grants are awarded to individual artists and arts organizations to create visual art, music, dance, theatre, film, and literary projects that benefit the residents of Dover and enrich the cultural life of the city.

The Cocheco Mills Historic Project in Fabric by Marielle Carpentier



Marielle Carpentier will create a permanent sculpture based on the history of Dover and the Cocheco Manufacturing Company. The goal of the project is to provide the Public Library with permanent artwork that is a representation of the city's history, as well as an engaging learning tool for the children of Dover. In addition, a workshop will be held to provide a meaningful activity that is part history lesson, art lesson, and home economics lesson.

Carpentier's sculpture will be a simplified representation of the main factory building in a T shape. Replica fabrics that reflect the popular textiles of the time will be used to make the sculpture. Carpentier describes the sculpture as "extremely child friendly, as it is essentially a giant pillow," and plans to have it donated and permanently displayed in the Dover Public Library.

Carpentier will also hold a workshop to teach children about textile history while educating them on patternmaking and sewing as they create their own custom pillow. The workshop is a two-part lesson. The first part will explain how to make a pattern or design, followed by time for children to design their own patterns. The second part of the workshop involves creating the final pillow. This layered physical and intellectual approach serves to connect the future with the past.

The Printmaking Project by the Dover Art Center



The Dover Art Center plans to organize an environmentally friendly printmaking shop which would be accessible to resident artists and members, and, most importantly, to aspiring young artists in Dover. The Art Center's newly acquired Takach Press was purchased through generous donations. Volunteers assisted both physically and financially to organize the new workshop area and move the press into place.

The Center would like to teach the art of printmaking (e.g., etching and monoprint, collagraph and solar print) to the many young people in Dover. Workshops for students will be held in collaboration with artist teachers and printmakers who are actively involved in The Art Center already. This will be a

one-of-a-kind opportunity in the Seacoast area.

Sally Dion is the residency director at The Dover Art Center and has 36 years of printmaking experience. Dion is now in her final term at Massachusetts College of Art and Design completing her master's degree in fine art. She specializes in printmaking utilizing unusual materials and compelling narratives. She has taught printmaking and design workshops in Southern New Hampshire and has exhibited her work throughout New England.

Rebecca Proctor, founder of The Art Center, is the creative mind and organizer of the project. Proctor has worked collaboratively in Dover's art community for over 14 years. She will see this project through from its inception to its completion and will be actively involved during the process.

City Council to hold public hearing July 22 on proposed rezoning

The City Council will hold a public hearing on proposed rezoning amendments on Wednesday, July 22, at 7 p.m., in the Council Conference Room at City Hall. The public hearing is open to all City of Dover residents, property owners and business owners.



The July 22 public hearing follows five public hearings held by the Planning Board this spring. The Planning Board unanimously adopted the amendments in June.

There are two sets of amendments, all of which are intended to promote economic development and improve quality of life in Dover. The first is a collection of syntax and terminology changes. These amendments focus on updating city code to ensure that current terms and titles are used, as well as maintaining references to state statutes and regulations. In addition to these terminology amendments, General Code,

the City's vendor managing the online representation of the City Code, has recommended renumbering some sections of the code to enhance readability.

The second set of amendments contains substantive changes, such as rezoning specific areas of the city, updating the Transfer of Development Right's Ordinance and creating and Alternative Energy Code.

The rezoning recommendations stem from a report presented by a committee tasked with reviewing nonresidential opportunities in Dover. In 2019, after reviewing transportation corridors and existing infrastructure, the committee developed its recommendation, which were then presented to the Planning Board. These items were adopted by the Planning Board in June 2020. The report can be viewed at <https://bit.ly/2BLan80>.

In addition to rezoning, many of the amendments focus on streamlining the existing zones and cleaning up inconsistencies. If all of the amendments are adopted, Dover's three commercial districts will be merged into one, two high tech and assembly zones will be merged into one, and a new commercial manufacturing zone -- a hybrid zone -- will be created. In addition, the recommendations include establishing a gateway zone. Parker explains that this zone is a rethinking of an existing zone.

Two other areas of the code being updated include expanding the City's Small Wind Energy Systems Ordinance to include solar and geothermal elements. This section, a recommendation of multiple chapters of the Master Plan and developed with the Energy Commission, creates guidelines for promoting solar power generation systems.

Finally, some of the proposed changes to Zoning Code promote more diverse housing options, primarily as part of the existing Transfer of Development Right's Ordinance. Dover's ordinance allows property owners to purchase development rights above what they have in the underlying zoning. The funds raised from these purchases are placed into the Conservation Fund and used to preserve and protect land in the community.

In 2018 the City developed a program to sell development rights for size-restricted homes. In its review, a Planning Board subcommittee recommended changes to the program to expand its use. Under the amendments before the City Council, there are four areas that look to incentivize the development of housing at sub-market rents:

- In manufacturing and commercial zones, for any assembly/manufacturing structure approved, and constructed, above 40,000 square feet, the property owner receives one dwelling unit per 2,000 square feet approved (for example, a 50,000-square-foot building nets five units). These can be used onsite as employee

housing, sold to other developers to be used citywide, or may be used by the property owner anywhere else in the City.

- In the Gateway zone, if a developer/property owner agrees to limit the rent to HUD fair market guidelines, the density changes from one unit per 4,000 square feet of lot size to one unit per 2,000 square feet.
- Through the Transfer of Development Right's Ordinance, if a developer/property owner agrees to limit the rent to HUD fair market guidelines, and creates a 600-square-foot or smaller detached unit or (no size limit) multifamily units, they pay no TDR fee.
- In the Residential/Commercial Mixed-Use District, if a single-family dwelling is limited to 1,000 square feet of total living area, density is one unit per 10,000 square feet of lot size; otherwise, it is one unit per 40,000 square feet of lot size.

City Council to form Committee for the Elimination of Racism and Bias, seeks applicants

The City Council will soon form an ad-hoc Committee for the Elimination of Racism and is seeking community members interested in sitting on the advisory panel. The committee will hold listening sessions, review data and develop an action plan intended to help identify and eliminate systemic racism in municipal operations, including public boards and commissions.

The advisory committee will report its recommendations to the City Council.

The City Council discussed the composition of the committee at its meeting on July 8. Members of the committee will likely include a City Councilor; a School Board member; a representative of Dover High School's Project DREAM; a member of the public representing the NAACP, ACLU, or similar organization with a mission that seeks to eliminate racism and promote racial justice and equality; a member of a field of academia with a focus on identifying and eliminating systemic racism/bias; and members of the community with knowledge, interest, and experience in addressing systemic

racism and bias. The number of community members is yet to be determined, pending interviews of applicants by the City Council's Appointments Committee.

Applications must be returned to the City Clerk's Office in person, by mail or by email. Applications will be reviewed in the coming weeks by the Appointments Committee.

The pending formation of a Committee for the Elimination of Racism and Bias follows the unanimous adoption of a resolution by the City Council in June that condemns systemic racism and acknowledges the effects of racial inequity on education and economic opportunities. The resolution states that Dover will continue to "strive to become increasingly welcoming, inclusive, representative, and responsive to historically underrepresented and underserved communities."

Assistance available through Dover's Welfare office, CAP

The state has authorized \$35 million from the CARES Act Coronavirus Relief Fund to support those in need of housing assistance as a result of COVID-19. Funds are available through New Hampshire's five Community Action Program (CAP) agencies.

The program is open to all New Hampshire residents and there are no income restrictions.

The program has two components: one-time assistance grants and a short-term rental assistance program.

- The one-time assistance grants cannot exceed \$5,000 and can be used to assist households with:
- Past-due rent from April 2020 forward for households that fell behind on rent due to either increased household expenses or lost household revenue as a result to COVID-19;
- Past-due housing/household related expenses that may impact an individual's/families' ability to remain housed; and/or
- Other housing related one-time expenses that if not paid impact the ability to maintain housing.
- The short-term rental assistance to maintain or secure permanent housing includes assistance for:
- Past-due rent that was not paid due to a COVID-19 related inability to pay and ongoing rental assistance on a short term basis. The rental assistance will decrease over time as households regain stability; or
- First month's rent and ongoing short-term rental assistance to assist with initial costs to facilitate the transition of working households from shelters into permanent housing.
- Program payments will be made directly to the landlord or provider, and this program will end by Dec. 30, 2020.

Self-employed business assistance applications due by 4 p.m. today

Gov. Chris Sununu has authorized the allocation and expenditure of CARES Act Coronavirus Relief Funds ("flex funds") to provide emergency financial relief to support New Hampshire self-employed, for-profit businesses due to the economic disruption caused by COVID-19.

The Self Employed Livelihood Fund is only available to businesses that apply by July 17, 2020. Late or incomplete applications will not be accepted. All businesses who feel as though they are eligible should submit an application; however, only businesses that meet all of the Self Employed Livelihood Fund grant criteria are eligible to receive an award.

The Self Employed Livelihood Fund grant award amounts will be calculated similarly to the Main Street Relief Fund, with the maximum award amount a business can receive is \$50,000.

The State of New Hampshire is not directing businesses on how to spend the money. Businesses must demonstrate they have experienced or anticipate they will experience a financial loss due to COVID-19 in order to qualify for a Self Employed Livelihood Fund Grant. It is expected that businesses will use the funds to assist in covering their operational costs and legal obligations.

The Application must be completed and submitted by 4 p.m. on Friday, July 17, 2020, using only the Department of Revenue Administration (DRA) web portal. No hand-delivered or mailed paper copies will be accepted. It is recommended that applications be finalized as early as possible before the deadline. Businesses that require assistance from the DRA may contact the Call Center at (603) 230-5000, Option 0, from 8 a.m. to 4:30 p.m., Monday through Friday.

The Dover Housing Authority serves 877 households per month with a federal rent subsidy. Rent paid by residents is based on 30 percent of household income. The mission of the DHA is "Opening Doors to Opportunities".

"Access to testing is one of the most powerful tools we can utilize in our efforts to remain safe against the COVID-19 virus," adds Chief Haas. "With a high level of support from Wentworth-Douglass Hospital, Dover Fire & Rescue's testing team is committed to protecting our most vulnerable populations. We are proud to partner with Wentworth-Douglass Hospital and the Dover Housing Authority to provide access to testing for this high-risk population."



Downeaster to expand service
beginning July 20

The Northern New England Passenger Rail Authority (NNEPRA) announced this week the Amtrak Downeaster will operate four round-trip trains each day beginning on Monday, July 20. The expanded service is Phase 2 of the Downeaster's service restoration.

Other Phase 2 service elements include the availability of onboard food service and the re-opening of some Downeaster station facilities. Several protocols and procedures have been implemented to protect the health and safety of passengers and crews, including:

Trains will be sanitized and disinfected daily with enhanced cleaning between trips.

Face coverings are required for crews and passengers on board trains and in stations.

The number of riders is limited to no more than 50 percent of available seating capacity to support physical distancing guidelines.

Amtrak's eTicketing allows for touchless tickets collection> Cash sales are not accepted at this time.

Enhanced cleaning, training and social distancing protocols have been implemented at the Downeaster Café, including installation of plexiglass partitions at the service counter and a pilot program for at-seat service. The Café table seating area will remain closed.

The Amtrak Downeaster currently operates one commuter train in operation southbound in the morning, and one northbound train departing from Boston at 5 p.m.

Slow the Spread of COVID-19



Use cloth face coverings to help slow the spread of COVID-19

COVID-19 spreads mainly from person to person through respiratory droplets produced when an infected person coughs, sneezes, talks, or raises their voice (e.g., while shouting, chanting, or singing). These droplets can land in the mouths or noses of people who are nearby or possibly be inhaled into the lungs. Recent studies show that a significant portion of individuals with COVID-19 lack symptoms (are "asymptomatic") and that even those who eventually develop symptoms (are "pre-symptomatic") can transmit the virus to others before showing symptoms.

To reduce the spread of COVID-19, CDC recommends that people wear cloth face coverings in public settings when around people outside of their household, especially when other social distancing measures are difficult to maintain.

Why it is important to wear a cloth face covering

Cloth face coverings may help prevent people who have COVID-19 from spreading the virus to others. Wearing a cloth face covering will help protect people around you, including those at higher risk of severe illness from COVID-19 and

workers who frequently come into close contact with other people (e.g., in stores and restaurants). Cloth face coverings are most likely to reduce the spread of COVID-19 when they are widely used by people in public settings. The spread of COVID-19 can be reduced when cloth face coverings are used along with other preventive measures, including social distancing, frequent handwashing, and cleaning and disinfecting frequently touched surfaces.

The cloth face coverings recommended here are not surgical masks or respirators. Currently, those are critical supplies that should be reserved for healthcare workers and other first responders. Cloth face coverings are not personal protective equipment (PPE). They are not appropriate substitutes for PPE such as respirators (like N95 respirators) or medical facemasks (like surgical masks) in workplaces where respirators or facemasks are recommended or required to protect the wearer.

State releases June unemployment numbers

New Hampshire's preliminary seasonally adjusted unemployment rate for June 2020 was 11.8 percent, reflecting the impact on unemployment due to the coronavirus (COVID-19) pandemic and efforts to contain it. This was a decrease of 3.6 percentage points from the May rate, which increased to 15.4 percent after revision. The June 2019 seasonally adjusted rate was 2.5 percent.


Seasonally adjusted estimates for June 2020 placed the number of employed residents at 656,580, an increase of 35,460 from the previous month and a decrease of 97,190 from June 2019. The number of unemployed residents decreased by 24,760 over-the-month to 88,260. This was 68,560 more unemployed than in June 2019. From May to June 2020, the total labor force increased by 10,700 to 744,840. This was a decrease of 28,630 from June 2019.

The unadjusted June 2020 unemployment rate for New Hampshire was 11.7 percent, a decrease of 3.6 percentage points from the May rate, which increased to 15.3 percent after revision. The June 2019 unadjusted rate was 2.5 percent.

Nationally, the seasonally adjusted unemployment rate for June 2020 was 11.1 percent, a decrease of 2.2 percentage points from the May rate, and an increase of 7.4 percentage points from the June 2019 rate. The national unadjusted rate for June 2020 was 11.2 percent, a decrease of 1.8 percentage points from the May rate, and an increase of 7.4

percentage points from the June 2019 rate.

The following events are recorded in "Notable Events in the History of Dover, New Hampshire: From the First Settlement in 1623 to 1865," by George Wadleigh, and several other historical sources.

July 19, 1683 - Foul weather set in after a drought, and continued until the beginning of September, to the great damage and almost ruin of husbandry.



July 17, 1817 - President Monroe, who took his seat on the 4th of March of this year, made a visit to New England, going from Boston to Portsmouth and Portland, and returning by way of Dover, which he reached this day. He was received at the line of the State by the committee appointed by the town authorities, conducted by the Marshals and select escort.



July 20, 1837 - Died, Deborah Coffin, the oldest person in town, having been baptised Sept. 17, 1738, She was born in the house on Central street which stood on the high bank which was dug away to make room for Varney's block, and in which her ancestors lived until the great earthquake in 1755 shook down the chimney. Her great grandfather was Peter Coffin, whose garrison stood on the spot where she was born, and whose house and mills were burnt when Major Waldron was killed by the Indians in 1689. It was a tradition of the family that when the Indians entered his garrison four of his hired men attempted to put them out, but the family prevented them believing they could trust the Indians. The Indians murdered the four hired men, but spared all the family. Her father had ten children, the eighth of whom was Deborah. She remembered that when she was young and the women went out to milk, a man went with them with a gun, for fear of the Indians. Much of the land on Washington street, granted originally to Peter Cffin, remained in the family until "Aunt Deborah's" death.



July 22, 1857 - Very heavy thunder showers - the lightning

striking No. 5 Factory, prostrating several of the help, and setting fire to the waste in one of the rooms.



July 21, 1864 - Another call of the President for 500,000 men was made at this time. The quota of the State was 6,502, and of Dover 149, the credits to which the city was entitled reducing this number to about 110. At a special meeting of the City Council held July 23, it was voted to pay the largest bounties for volunteers authorized by a recent act of the Legislature: \$100 for 1-year men, \$200 for 2-year men, and \$300 for 3-year men; and the Mayor was authorized to take immediate measures for carrying the vote into effect, and raising the necessary men.


Historic Walking Tours: Summer 2020
