## School Board receives proposed FY24 budget

Superintendent William Harbron and Business Administrator Michael Limanni presented the School Department's budget at the School Board meeting this week, kicking off the FY2024 budget cycle.

Harbron and Limanni stressed the budget is still being refined, and a more detailed budget would be presented to the School Board at its first budget workshop on Monday, Nov. 28.

At the budget workshop, department heads will be on hand to discuss the new position requests included in the preliminary budget with information on the positions, why they are requested, and the data to support the need for them, Harbron told the School Board.

Limanni said the business office is in the process of completing a payroll audit. He noted the preliminary budget is currently level-funded for staff and does not include step increases; those numbers will be updated once the audit is complete and be presented to the School Board at a later workshop. The draft budget also does not include any significant contracts that are out for bid or in negotiations, according to the documents. The initial budget figure is \$78,687,787, a \$4,459,207 increase over the current fiscal year. This figure includes the requested new positions, which total \$2,330,980, according to the budget handout.

The preliminary budget does not include a tax cap calculation for the property tax levy; a preliminary tax cap figure is expected in

early December. The tax cap is the maximum amount the city and school portions of the property tax levy can increase in the next fiscal year budget and be adopted by a simple majority vote of the City Council. It incorporates inflation from the Consumer Price Index and a net increase in new construction. Anything above the tax cap requires a two-thirds majority of the City Council to adopt.

School Board budget workshops will continue through December and early January. It must be adopted and submitted to the City Manager by Jan. 15, per city ordinance. The City Council is required to adopt a city-wide budget by April 15.

## City seeks to rebid waterfront public improvements after receiving no bids

City of Dover staff are working on repackaging the bid for the public improvements to the city-owned waterfront development site after none of the four prequalified firms submitted a bid for the project.

Project Manager Steve Bird updated the Cochecho Waterfront Development Advisory Committee (CWDAC) Tuesday on some reasons why no bids were received learned from conversations with the firms following the Oct. 26 bid closing date.

Bird said that all of the firms expressed concern about not being able to complete some of the required shoreline work by the March 15, 2023, deadline set by the permit issued by the Army Corps of Engineers. Other reasons include not getting the cost estimates from subcontractors and the firms being too busy with other work to begin the waterfront work by December or early January.

Bird said the city is working with the Army Corps of Engineers to transfer the existing permit to a new one, allowing work from September through March 15, 2024. Engineers are also revising the bid in response to some of the questions raised by the potential bidders.

The goal is to release a revised bid by the end of the year and have the City Council award a

bid by mid to late winter to allow work to begin later than spring. Construction work on the streets, utilities and creating pad sites for the waterfront development is not affected by the March 15 deadline.

The bids were sent to NorthEast Earth Mechanics, LLC., of Pittsfield, Severino Trucking Co, Inc., of Candia, S.U.R. Construction, Inc., of Rochester, and Sargent Corporation of Stillwater, Maine, which were prequalified through a [request for qualifications](#) the city released on Feb. 24, 2022.

In other CWDAC news, the committee endorsed the findings of the CWDAC Park Subcommittee on creating a new crew building, as the current one will be removed to allow the construction of the waterfront project. After meeting for the past year with stakeholders, the subcommittee, chaired by Norm Fracassa, agreed the best of the alternatives was to create a new building within the park. The idea is that the land would be leased to Great Bay Rowing, which would be responsible for the building's permitting, design, construction and maintenance. With the endorsement, CWDAC will continue to develop the proposal.

## Dover's mental health challenges and response is topic of Saturday forum

Join the Dover Mental Health Alliance on Saturday, Nov. 19, 2022, to hear the preliminary findings of a yearlong study: Services Response to Mental Health Crisis in the City of Dover.

Like many communities, Dover has experienced a dramatic rise in demand for mental health crisis services in recent years. Facilitated by the Center for Ethics in Society at Saint Anselm College, a subcommittee of the Dover Mental Health Alliance Task Force was asked to develop a set of recommendations that reflect trends, obstacles, opportunities, and best practices to follow as they relate to ongoing City response to mental health related calls for service and needs.

In this third public program on Dover's mental health crisis services, the subcommittee will share its final recommendations with the community for feedback and comment. These recommendations are the result of nine months of work in collecting research and data, consulting local experts, and hosting public discussions about mental health crisis intervention in Dover.

The discussion will be held in the Dover High School library. Those who attend in person are invited to arrive at 8:45 a.m. for coffee and to informally review the recommendations before the event begins. The live webinar will begin promptly at 9 a.m.

## New land acknowledgment plaques to be installed at city facilities

### Unveiling of first plaque to be held Nov. 28

On Monday, Nov. 28, the City of Dover will unveil the first of several bronze plaques bearing a land acknowledgment to the area's indigenous peoples. The ceremony will be held at the Dover Public Library, beginning at 6 p.m. The bronze plaques are made possible thanks to a generous grant by the New Hampshire Humanities Council. The unveiling will be followed by a special presentation on indigenous land stewardship, with guest speakers Paul and Denise Pouliot, the Sag8mo and Sag8moskwa (Male and Female Head Speakers) of the Cowasuck Band of the Pennacook Abenaki People; and Kathleen Blake, affiliate faculty of the University of New Hampshire Native American and Indigenous Studies Minor.



The New Hampshire Humanities Council grant, which was approved by the City Council earlier this year, helped create Indigenous Dover, an initiative to help better understand and appreciate the history of the indigenous peoples who were here in what is now called Dover, thousands of years before the first European settlers.

The City Council adopted a land acknowledgment last year, which had been proposed by the Council's ad-hoc Committee on Racial Equity and Inclusion (CREI). Dover's land

acknowledgment at city facilities will state: “This facility is located at Cochecho (CO-chi-co) on N’dakinna (n-DA-ki-na), now called Dover, New Hampshire, which is the unceded traditional ancestral homeland of the Abenaki (a-BEN-a-ki), Pennacook and Wabanaki Peoples, past and present. We acknowledge and honor with gratitude the land, waterways, living beings, and the Aln8bak (Al-nuh-bak), the people who have stewarded N’dakinna (n-DA-ki-na) for many millennia.”

## Road closures and parking restrictions for Thanksgiving Day 5K race

Breault announces the following road closures and parking restrictions for the annual Dover Turkey Trot 5K run/walk event, organized by and benefitting the Garrison Elementary School Parent-Teacher Association. The following road closures will be in effect on Thanksgiving Day, Thursday, Nov. 24, to accommodate the race that begins at 8:30 a.m.

- From 8:20 to 8:35 a.m., Shaws Lane will be closed in both directions between Garrison Road and Tideview Drive to accommodate the start of the race;
- From 8:30 to 9:30 a.m., Garrison Road will be closed in the westerly direction at Morningside Drive, with traffic diverted through the Morningside neighborhood.

Between 8:30 and 9:30 a.m., motorists should expect additional delays or temporary street closures in the following locations:

- Back River Road and Garrison Road;
- Garrison Road and Shaws Lane;
- Back River Road and Spruce Lane;
- Mast Road and Spruce Lane;
- Linda Avenue, Riverdale Avenue and Morningside Drive.

## State seeks to dismiss Dover’s redistricting lawsuit

### City of Dover’s objection to motion to dismiss is latest court filing

The City of Dover filed this week an objection to the Secretary of State and the State of New Hampshire’s motion to dismiss the lawsuit filed by Dover and other parties that argues the legislatures’ redistricting law violates New Hampshire Constitution’s Part II, Article 11.

The defendants argue the plaintiffs’ claims “present a nonjusticiable question and fail to state a claim upon which relief may be granted,” suggesting the court “resist the plaintiffs’ invitation to impose a judicially-decreed political solution to a legislative political problem.” The plaintiffs object, arguing that the “claims in this case do not come close to ‘political questions,’” and request the court to schedule a hearing and deny the state’s motion to dismiss.

The lawsuit centers around how state legislators drew redistricting maps following the release of the 2020 Census data in 2021. House Bill 50, signed into law on March 23, 2022, groups Dover's Ward 4 residents into two districts combined with other towns. The complaint alleges that other municipalities, including Barrington, Hooksett, Lee, New Ipswich, Rochester and Wilton, had combined representation with neighboring municipalities, despite New Hampshire Constitution requirements requiring a dedicated district for political wards and towns with sufficient population.

The City of Dover filed the lawsuit against the state in July. Joining the suit was the City of Rochester and 10 voters from various municipalities, including Ward 4 Councilor Debra Hackett in her personal capacity only and not as a city councilor. The plaintiffs' complaint seeks the court to either redraw or order the state to redraw the house representation maps for the affected towns and wards in compliance with the state constitution.

The lawsuit follows the New Hampshire Supreme Court's May 17 denial of the City of Dover's petition for the court to take original jurisdiction of the city's request for the Supreme Court to review the constitutionality of the redistricting legislation directly. The city had sought the Supreme Court to address the matter directly to obtain a ruling on the merits in advance of the 2022 elections related to the New Hampshire House of Representatives.

## **Downtown Central Avenue corridor to close for parade from 2:45 to 4:45 p.m.**

Dover Police Chief William M. Breault announces the following road closures and parking restrictions for the Dover Holiday Parade, which returns after a three-year hiatus. The parade begins at 3 p.m. on Sunday, Nov. 27, 2022, and will follow its traditional route along Central Avenue (NH Route 108), starting at the Greater Dover Chamber of Commerce, 550 Central Ave., and finishing at 120 Central Ave., next to Cleary Cleaners and across from Pine Hill Cemetery.

On Sunday, Nov. 27, Central Avenue will be closed to all traffic from 2:45 to 4:45 p.m. from the intersection of Chestnut and New York streets to Stark Avenue and East Watson Street. Temporary traffic detours will be in effect.

Additional street closures will be in effect from 11:30 a.m. to 4 p.m. to accommodate parade staging and setup. These include:

- Sixth Street, between Horne Street and Central Avenue;
- Maple Street, between Sixth and Hough streets;
- Grove Street, between Fifth and Hough streets;
- Mt. Vernon Street, between Sixth and Milk streets.

Parking restrictions will be posted to prohibit on-street parking on Sixth Street between Horne Street and Central Avenue, beginning at 9 a.m. on Sunday, Nov. 27, and in other locations where necessary along the parade route. Parking is allowed on most of the parade route, but motorists will not be permitted to move their vehicles during the Central Avenue closure.

Dover Police are coordinating with CSX Transportation railways to temporarily suspend freight trains at the downtown crossings to accommodate the event. Amtrak Downeaster passenger train service will not be interrupted. For information about traffic, contact the Traffic Bureau at 603-742-4646.



The following events are from a variety of historical records, sources and texts about the history of Dover.

**Nov. 20, 1832** — The bells of the town tolled and guns fired as a token of respect for the memory of Charles Carroll of Carrollton, the last signer of the Declaration of Independence, who died Nov. 15.

**Nov. 20, 1841** — The town voted to distribute surplus revenue, except for what had been appropriated to the payment of poll taxes, in equal proportions among the legal voters of the town and the widows of citizens.

**Nov. 19, 1856** — Two young men, George S. Clark, aged 26, and John Foss, aged 23, were killed by the premature discharge of a cannon which they were firing on Garrison Hill to celebrate the election of President James Buchanan. **Nov. 20, 1920** — The Hotel Leighton on Third Street advertises a Thanksgiving dinner for \$1, beginning at noon on Thanksgiving. Among the dishes served are Consomme Britaniere Royal, Roast Stuffed Vermont Turkey, Roast Stuffed Chicken with Giblet Gravy, Fried Fillet of Sole, Green Apple Fritters, and a wide variety of soups and sides.

**Nov. 20, 1930** — The keys to the new National Guard Armory in Dover were turned over to Battery B. It was formally opened to the public on Nov. 25.



## **Celebrate N'Dakinna and the life of indigenous people on the Cochecho**

Join the Dover Public Library on Monday, Nov. 28, at 6:30 p.m. for a lecture on indigenous land stewardship. This event is made possible by a grant from New Hampshire Humanities.

Around 12,000 years ago, indigenous tribes began to make their home along the Cochecho River. Collectively these tribes were known as the Abenaki or "People of the Dawnland."

Throughout the month of November, the City of Dover is recognizing and celebrating the indigenous peoples and tribes of what is now Dover.

The Nov. 28 presentation will be held in person, with the option to view it virtually. Speakers include Paul Pouliot, Denise Pouliot and Kathleen Blake, affiliate faculty of the University of New Hampshire Native American and Indigenous Studies Minor, as well as members of the

The lecture will feature a short history of indigenous foodways, and the traditional use of waterways and land along the Cochecho. The presentation will also focus on contemporary efforts being made by indigenous groups to care for the ancestral homelands and how attendees can support these programs.

Attendees are invited to meet before the lecture at 6 p.m. for a special ceremony as the library unveils a new land acknowledgment plaque, a citywide initiative funded by a generous grant through New Hampshire Humanities in partnership with the National Endowment for the Humanities.

Paul and Denise Pouliot are the Sag8mo and Sag8moskwa (Male and Female Head Speakers) of the Cowasuck Band of the Pennacook Abenaki People. Paul is an indigenous historian, lecturer, and a founding member of the New Hampshire Commission on Native American Affairs where Denise currently serves as Vice Chair. In her spare time, Denise creates coil, bark or woven baskets and produces traditional ceremonial clothing. Together they serve as Federal Religious Advisors and are recipients of the UNH Platinum Sustainability Award for community building. They were also named as one of The Nature Conservancy's 60 individuals and organizations that have positively impacted the natural world in honor of TNC's 60 years of conservation in New Hampshire.

Kathleen Blake is a retired teacher of biology, ecology and earth science. She spent several years as a science curriculum and assessment specialist. She is of mixed heritage whose indigenous descendance is from the Wendat (Huron), Algonquin, Anishinabe, and Mi'kmaq peoples. Blake served as chair for the New Hampshire Commission on Native American Affairs for several years. She is currently serving as a board member of the Racial Unity Team, a member of the Dover Racial Equity and Inclusion Committee, and the Dover School Department Vision Keepers. She is dedicated to supporting and serving the first peoples of this land.

## **SEED gets grant from New Hampshire Charitable Foundation**

The Seacoast Educational Endowment for Dover ("SEED"), a nonprofit organization dedicated to lifting academic excellence in Dover public schools, announced this week it has been awarded a New Hampshire Charitable Foundation grant. The grant, valued at \$3,409, will help underwrite future grant cycles and provide teacher-classroom support.

A registered non-profit, SEED has provided financial support to Dover public schools for 10+ years. Twice annually, SEED invites educators to present learning proposals outlining the 21st-century learning projects they would like to initiate. The SEED Board of Directors reviews applications and selects projects to fund through grant awards.

SEED supports three focus areas: instructional projects, innovation (tools, techniques, technology), and educator development. ## **American Red Cross lifeguard training and recertification course**

The Dover Indoor Pool will host the American Red Cross lifeguard training program the first two weekends of December at half the regular price of the training. Participants seeking to become lifeguards must attend all training sessions and be at least 15 years old on the last day of the class. The training will be held on Saturday, Dec. 3 and 10, from 11:30 a.m. to 4:30 p.m., and Sunday, Dec. 4 and 11, from 10 a.m. to 4 p.m. Recertification will be held on Sunday, Dec. 11.

The American Red Cross lifeguarding training program teaches participants the knowledge and skills to prevent and respond to aquatic emergencies. The course includes the latest science in first aid, CPR/AED for the professional rescuer, emergency cardiac care, and lifeguarding rescue skills and safety protocols.

Those seeking to take the course must meet the following prerequisites.

- Swim 300 yards continuously;
- Tread water for two minutes;
- The participant must be able to do the following within 1 minute and 40 seconds, starting from the water: swim 20 yards using front crawl or breaststroke, surface dive 7 to 10 feet, retrieve a 10-pound object, return to the surface, swim 20 yards back to the starting point with the 10-pound object and exit water without using a ladder;
- No refunds will be given for failing to meet prerequisite requirements.

The holiday season discounted price of the complete course is \$150 (regularly \$300). To be recertified, the price is \$60.
