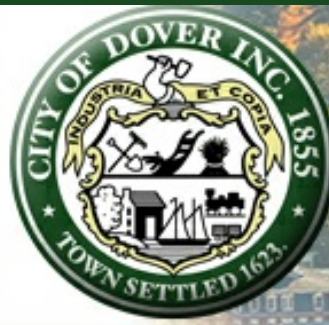

## State General Election is Tuesday

The state general election will be held on Tuesday, Nov. 8, 2022, and polls in Dover will be open from 7 a.m. to 7 p.m. Absentee ballots are available to voters who cannot make it to the polls that day.

The election ballot includes races for federal, state and county offices, including Governor, U.S. Senator, Representative in Congress, Executive Councilor, State Senator, State Representative, Sheriff, County Attorney, County Treasurer, Register of Deeds, Register of Probate and County Commissioners. The ballot also includes two constitutional questions.

## Polling locations

Dover has the following six polling places:

- Ward 1 - [Frances G. Hopkins Elementary School \(formerly Horne Street Elementary School\), 78 Horne St.](#)
- Ward 2 - [Dover Ice Arena, 110 Portland Ave.](#)
- Ward 3 - [Woodman Park Elementary School, 11 Towle Ave.](#)
- Ward 4 - [Garrison School, 50 Garrison Road](#)
- Ward 5 - [Dover Middle School, 16 Daley Drive](#)
- Ward 6 - [Hellenic Center, 219 Long Hill Road](#)

Voters may only vote in the ward where they live. Please note: On Feb. 9, 2022, the City Council [adopted](#) new ward boundaries through an ordinance change to ensure near-equal representation in Dover's six political wards based on 2020 Census Data. This ward redistricting affected about 1,500 voting households in Dover, informed by mail from City Clerk Susan Mistretta earlier this year.

Voters whose wards have changed will vote in different polling locations than their previous ward. Residents may check which ward they live in utilizing the [interactive ward map](#).

## Absentee ballots are available at City Clerk's Office

Absentee ballots for the Nov. 8, 2022 election are available at the City Clerk's Office. Per state law, voters may cast an absentee ballot if they will be absent on election day, cannot appear in public on any election day because of their observance of a religious commitment, or is unable to vote in person because of a physical disability. Voters who cannot get to their polling place during polling hours because of an employment obligation or caring for others may also vote via absentee ballot.

Absentee ballots can be handed into the City Clerk's Office up to 5:30 p.m. on Monday, Nov. 7. Mailed absentee ballots must be received at the Clerk's Office by Tuesday, Nov. 8.

## **COAST to offer free rides to the polls on Election Day**

COAST will offer free rides to anyone on their way to vote on Tuesday, Nov. 8.

While the COAST public transit system does not provide transportation to each individual polling station directly, their hope is to encourage voters to get to the polls and participate in voting by eliminating the barrier of transportation costs.

All passengers need to do is tell their driver that they are on their way to vote, or on the way back from voting, and they will not be charged for the ride. COAST will be following an honor system.

## **Dover to receive \$250K InvestNH Municipal Planning and Zoning Grant to help increase housing development opportunities**

### **Apartment project at site of former McIntosh College receives \$2.8 million from program**

The City of Dover was awarded a \$250,000 InvestNH Municipal Planning and Zoning Grant to fund a Community Housing Navigator position for the next two years. The grant is part of Gov. Chris Sununu's \$100 million InvestNH initiative, with \$5 million allocated to assist municipalities in analyzing and updating their land use regulations and helping increase housing development opportunities.

The purpose of the InvestNH Municipal Planning and Zoning Grant Program is to assist municipalities in hiring staff dedicated to increasing housing opportunities through community engagement and coordination of regulatory change. The grant application submitted by the Planning Department conveyed Dover's commitment to engage local stakeholders and work with regional groups to solicit ideas and implement regulatory changes. The award of this grant is in recognition of the Dover City Council and the Planning Board's ongoing efforts to advance the availability of varied forms of attainable housing throughout the community.

InvestNH is funded through the Governor's Office for Emergency Relief and Recovery. It utilizes the state's allocation of federal fiscal recovery funds overseen by the New Hampshire



Department of Business and Economic Affairs (BEA), which contracted with New Hampshire Housing to administer the Municipal Planning and Zoning Grants. New Hampshire Housing collaborated with Plan NH and the University of New Hampshire Cooperative Extension's Community and Economic Development to solicit and review grant applications.

Earlier this week, the Governor and Executive Council also awarded \$49,506,378 in InvestNH grants to developers to increase the number of affordable rental units in the state. The McIntosh Dover Apartments, which will be built at the former McIntosh College campus off Rutland Street, was awarded \$2,800,000 to create 52 affordable units out of a total of 156 units. The grant is administered through the BEA.



## **Setting of tax rate delayed; Council resolution would allow tax anticipation note**

### **Public hearings to be held on resolutions to accept, expend grant funds for Police Department**

At its Wednesday, Nov. 9, meeting, the City Council will hold a first reading and schedule a public hearing for Nov. 30 on a resolution that would authorize the issuance of a tax anticipation note (TAN). The potential need for a TAN is due to a delay in the School Department's submittal of required documents to the state. The city cannot produce and issue tax bills for the current tax year until the Department of Revenue Administration (DRA) certifies the city's tax rate.

City Manager J. Michael Joyal, Jr., notified the Council that while he seeks authorization for the TAN, the city would only proceed if needed before tax receipts begin arriving.

"Typically, we strive to have a certified tax rate from DRA and have tax bills mailed by mid-November with a due date for the first half tax payment no later than mid-December," Joyal wrote to the Council. "The timing for the receipt of the certified tax rate and our issuance of tax bills is critical to ensure we have sufficient cash receipts on hand to make a debt service payment on Dec. 15 and the county tax bill, due in full, on Dec. 16 of each year."

Tax anticipation notes are authorized by state law; a TAN requires a public hearing and a two-thirds affirmative vote of the City Council to authorize.

Joyal said the delay in obtaining a certified the tax rate is due to the delay in finalizing School Department forms for estimated revenue and prior-year financial information to the state, which the DRA requires to proceed with the issuance a certified tax rate.

"There have been ongoing staffing challenges being addressed within the School business office, and there remains a number of accounting transactions to be reviewed for the School Department to close out the FY2022 budget year," Joyal wrote. "The School Department is aware of the impact this is having on tax-rate setting and has been working to expedite the completion of their year-end accounting work."

Also on the Nov. 9 agenda are three public hearings and subsequent resolutions for the Council to accept and expend grant funds for the Dover Police Department.

One is for a \$250,000 Department of Justice Community Oriented Policing Services (COPS) grant to fund two police officers to enhance the Police Department's ability to respond to incidents involving mental illness and substance misuse.

Another is for a \$1,875,000 Partnership for Success Grant from the U.S. Substance Abuse and Mental Health Services Administration. The grant would be used to "build capacity to launch effective, data-driven collaborative community-based strategies to prevent the onset and reduce the progression of substance misuse and its collateral problems while promoting mental health and wellbeing," the resolution background materials state.

The last is a \$200,000 grant from the Sober Truth on Preventing Underage Drinking Act (STOP Act), also funded by the U.S. Substance Abuse and Mental Health Services Administration. "The STOP Act grant is designed to prevent and reduce alcohol use among youth and young adults ages 12-20 years old and reduce negative consequences associated with underage drinking," the resolution states.

## Daylight Saving Time a reminder for fire safety and prevention

Daylight Saving Time ends on Sunday, Nov. 6, at 2 a.m. It's a good time to change and test the batteries in smoke alarms and carbon monoxide detectors.

Dover Fire and Rescue reminds residents that one simple step can help save their lives and the lives of those around them. Everyone is encouraged to use Daylight Saving Time as a reminder to change the batteries in smoke alarms and carbon monoxide detectors, test alarms and remind friends, family, neighbors and fellow community members to do the same.

"Eighty percent of child fire fatalities occur in homes without working smoke alarms," said Dover Fire Chief Michael McShane. "It's a tragic statistic that could be reduced by ensuring you have an appropriate number of smoke detectors where you live and adopting the simple habit of changing your batteries when you change your clocks. If you have hardwired detectors, replacing the batteries at these intervals helps to ensure they can withstand the duration of a potential power outage at any time during the year."

According to the National Fire Protection Agency, 71 percent of smoke alarms which failed to operate had missing, disconnected or dead batteries. Changing smoke alarm batteries at least once a year, testing those alarms and reminding others to do the same are some of the simplest, most effective ways to reduce these tragic deaths and injuries.

"The peak time for home fire fatalities is between 11 p.m. and 7 a.m., when most families are sleeping," McShane said. "Smoke alarm maintenance is a simple, effective way to reduce home fire deaths. Children and senior citizens are most at risk, and a working smoke alarm can give them the extra seconds they need to get out safely."

A working smoke detector doubles your chance of surviving a home fire.

## **Energy Commission to hold public hearing on draft Electric Aggregation Plan for Dover**

# Community Power program

The Dover Energy Commission will hold the first of two public hearings on its draft Electric Aggregation Plan (EAP) on Nov. 16, part of efforts to initiate a Dover Community Power program.

If enacted, the program is authorized under RSA 53:E to provide electricity supply service for the city's residents, businesses, municipal operations and other types of customers on a competitive and voluntary basis. The program will only launch if it can initially offer residential default electricity rates lower than those offered by Eversource. The program will be self-funded through revenues generated by participating customers and not use taxpayer funds to cover program expenses.

The draft plan, [available here](#), once finalized and enacted, would serve as the blueprint for the Dover Community Power program's operation. The Dover Energy Commission, which the City Council designated as the city's Electrical Aggregation Committee (EAC) for the program, will take feedback at the public hearings before finalizing the EAP and sending it to the Council for its consideration. If approved by the Council, it would require further steps, including review by the Public Utilities Commission.

The Dover Community Power program is part of the non-profit Community Power Coalition of New Hampshire (CPCNH) initiative, of which the City of Dover is a founding member. CPCNH is overseen by a board of directors comprised of appointed members from participating communities. Last year, the City Council authorized the City Manager to execute a Joint Powers Agreement as part of joining CPCNH, allowing Dover to partner with other municipalities as they work to establish community power programs through the Coalition. The goal is for the participating communities to use their combined purchasing power to create savings and new value for customers. The EAC aims to have Dover Community Power operating beginning in calendar year 2024. Once operational as envisioned under the current draft plan, residents and businesses on default electricity supply through Eversource would be enrolled in the Dover Community Power program with the ability to opt out back to the default energy supplier through Eversource or choose a competitive energy supplier. Customers enrolled with competitive suppliers would be able to opt-in to the program. All customers will be noticed well in advance of the potential launch date.

Dover's EAC provides the Council advisory support during the development of the Dover Community Power program. The EAC encompasses all Dover Energy Commission members, who have a variety of energy expertise, with backgrounds including regulatory processes, utility operations, electric vehicles, energy data and offshore wind. The EAC is supported by Resilience Manager Jackson Kaspari, who has his doctorate in chemistry. The EAC tasked Kaspari, who serves on the CPCNH Risk Management Committee, with drafting language for the EAP. The EAC's business is conducted during public meetings of the Energy Commission, and related items are included in the Energy Commission's agendas and minutes.

The public hearing will be held at 5:30 p.m. on Wednesday, Nov. 16, in the McConnell Center cafeteria. Following public input, the EAC will schedule a second public hearing at a subsequent Energy Commission meeting.

## Skatepark construction moves to next year

### Most site work to be completed this fall

The construction of the new Dover skatepark is now slated to begin next year, with work slated to begin in late spring or early summer.

Skatepark construction was planned to begin at Guppy Park in late summer and be completed this fall. However, once the project received approval from the Planning Board in late July, the park contractor was working on another project and could not return until mid to late September, Recreation Director Gary Bannon told the Recreation Advisory Board in a recent meeting. If the contractor started at that point, it was not likely to finish work before winter, and



there would be additional costs of fencing the area to protect it during the winter months before it could be completed in the spring.

The construction of the new skatepark is now slated to begin in late spring or early summer 2023, Bannon said. Despite the delays, the contractor, Artisian Skate Parks, would still complete the project within the budget available, Bannon said. The construction of the skatepark would be the first phase of the project. As currently envisioned, the skatepark would include three elements, the main skate park, a skate bowl and a BMX pump track. The skate park will be built first, followed by the bowl and pump track in a future phase as funding allows.

Other preparation site work at Guppy Park is still slated to occur this fall. Bannon said he expects that by the end of the year, about 75% or more of the site work will be complete, including installing lighting poles and laying the foundation for a park shelter donated by the Rotary Club of Dover.

## Dover Police warn residents of phone scam

Chief William Breault of the Dover Police Department would like to alert the public regarding scam phone calls being perpetrated by individuals posing as members of the Dover Police Department.

On Oct. 31, 2022, numerous Dover residents called police after receiving a suspicious phone call in which the caller told residents that they were “under investigation” or “missed jury duty” and would be fined \$3,500. The residents were instructed to pay the fine immediately to avoid arrest.

This type of scam has been used nationally. The caller(s) pose as representatives from various law enforcement agencies and threaten arrest, prosecution, and imprisonment unless paid. They will demand payment via QR code, gift card, or ask for personal information such as a social security number or date of birth. Suspects often target the elderly and can be aggressive on the phone.

This is not a method used by any actual law enforcement agency. The Dover Police Department does not make requests for payment over the phone. People are reminded to never release personal or financial information over the phone unless they initiated the call and are certain who they are speaking with.

Any phone calls of this nature should be viewed with skepticism and reported directly to the police department. If a member of the police department contacts you and you have concerns that the person is misrepresenting themselves, you are encouraged to verify this person’s identity by contacting the Dover Police Department at 603-742-4646.

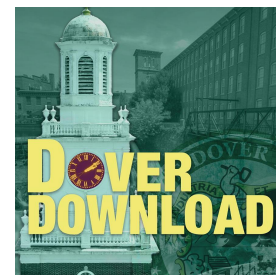

The following events are from a variety of historical records, sources and texts about the history of Dover.

**Nov. 8, 1683** — Was exceedingly dark, from 10 in the morning until 2 in the afternoon, caused by a very black and thick cloud passing over very low. It seemed as though the sun had been greatly and totally eclipsed.

**Nov. 7, 1774** — A town meeting was held to see if the inhabitants would raise anything, either "in money, fat cattle or sheep," for the relief of the poor of Boston, then suffering from the operations of the Port Bill. And it was voted that the town would "give something."

**Nov. 6, 1818** — Died, Capt. John Riley, aged 66. His death was occasioned by a fall from the staging of a ship building in this town, two days previous, by which both his thighs were broken and mangled in the most shocking manner. He has left numerous family to mourn the loss of a kind husband and father and true friend. (Strafford Register)

**Nov. 5, 1940** — Alfred Colby, president of the Pacific Mills Corporation, issued a statement on this day saying the Dover mills owned by the company would close permanently. Colby said the reason for the closure was due to the lackluster response to rayon, which the mills were then manufacturing to replace cotton. Colby said the mills would remain open until all orders were filled. Mayor Samuel Blair was told the same day the company's water rights, buildings, machinery and land would be sold once the orders were complete and the mills shuttered for good, likely within a few months. The mills at the time of the announcement employed nearly 1,000 people.

**Nov. 8, 1999** — The Dover School Board recognized Dover High School senior Kori Goulet for winning the NHIAA Girls Golf Individual Championship for the 1999 season. The championship title was her second, having earned it first as a freshman. Goulet then was a four-year member and co-captain of the school's golf team. She had also earned a second-place ranking on the mixed boys and girls team. In a resolution read by the School Board, Goulet was commended for exhibiting "consistent discipline, exemplary sportsmanship, quiet determination, and enthusiasm for the game of golf." Goulet would go on to become a professional golfer, participating in her first professional golf event in New Hampshire in 2006. She made her professional debut at the Massachusetts Open in August of 2005, where she finished second. She then moved on to play on the inaugural National Golf Association's Hooters Professional Golf Tour, where she played in five events.

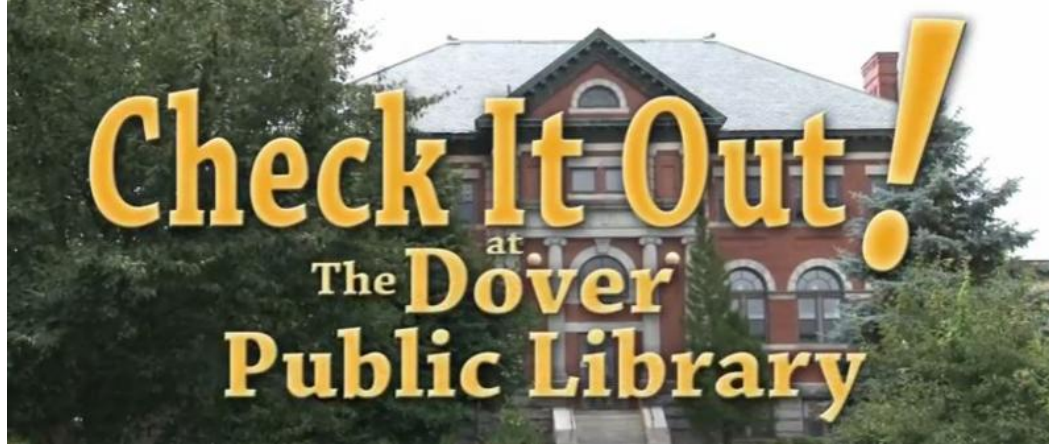

## History of the USS Albacore at Dover Public Library

Nestled away off the highway in Portsmouth is 204 feet of steel that changed Naval history forever.

Join the Dover Public Library on Wednesday, Nov. 9 at 6:30 p.m. for an early Veteran's Day program exploring the history of the USS Albacore and those who served on it. The in-person program will be presented by Patti Violette, executive director of the USS Albacore Museum.

The USS Albacore was designed and maintained by the craftsmen of the Portsmouth Naval Shipyard and holds the distinction of being the first boat built specifically to operate underwater. Prior to its creation, submarines served as surface vessels that could submerge. It also was the first designed with the teardrop-shaped hull, which is now the standard for today's submarines.

Commissioned in 1953, the USS Albacore served as the Navy's "floating laboratory", testing equipment, control systems, and innovative theories, until 1972. It wasn't until May of 1985 when the submarine made its way back home to Portsmouth.

Violette is the USS Albacore Museum's first woman director and fourth in its history. She has over 20 years of experience in the museum industry including Old Fort Western in Augusta, the Shirley-Eustis House in Roxbury and the Mount Kearsarge Indian Museum in Warner. She has a master's in education from Thomas College and an undergraduate degree in history from the University of Southern Maine in Portland.

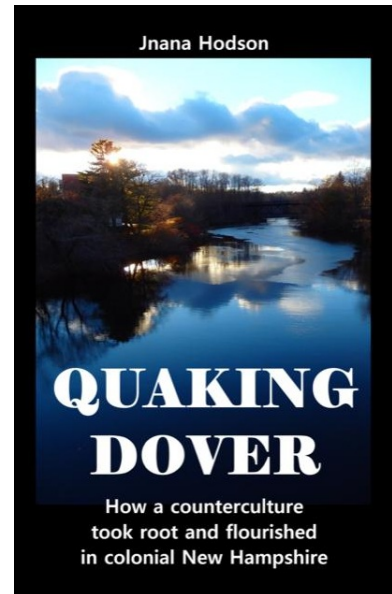
## Dover Friends to host 'Quaking Dover' book launch

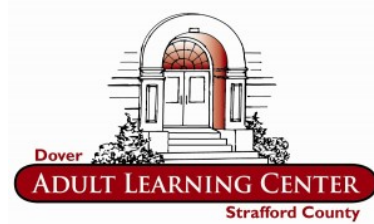
