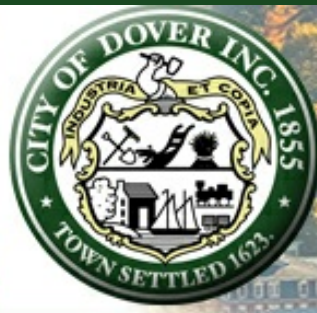

Skate park grand opening is Oct. 21

**Event coincides with skate competition
to benefit Dover Children's Home**

While it's been open for the past few weeks, the city will hold an official grand opening ceremony of the new Dover Skate Park at Guppy Park on Saturday, Oct. 21 at 12 p.m.

Mayor Robert Carrier, Recreation Director Gary Bannon along with members of the Dover Skatepark Design Committee and Recreation Advisory Committee will be on hand for park dedication, which has been years in the making.

The ceremony will take place during the Ryder Street Co

Skate Jam, which runs from 11 a.m. to 4 p.m. at the new park. The beginner's session starts at 11 a.m., followed by the main event, which includes the Best Ollie, Rail Jam and Game of Skate competitions. There will also be food trucks and music at the event. All proceeds will benefit the Dover Children's Home. [Click here](#) to register, which is free.

Construction on the skatepark began in June, which followed work preparing the site for construction last year. In 2021, the City Council awarded the bid to construct the skatepark to Artisan Skateparks of Kitty Hawk, North Carolina, for a cost not to exceed \$500,000. There are a few remaining items to be completed at the site, such as landscaping, drainage system work and the installation of picnic shelter.

Tri-City mayors seek new operator for Willand Warming Center

As the colder months approach, the Tri-City Mayors of Rochester, Dover, and Somersworth this week issued a [Request for Proposals](#) (RFP) in collaboration with the Strafford County Commissioners to identify a qualified operator for the Willand Warming Center, located at 30 Willand Drive in Somersworth.

Last year, SOS Recovery Community Organization was the sole respondent to the previous RFP to manage the Willand Warming Center. SOS provided management and staff, ensuring shelter and support for community members in need of warmth during extreme cold weather conditions. Recently, the organization regrettably communicated it is unable to continue due to staffing concerns and other logistical challenges.

The key distinction between seasonal warming centers and year-round shelters is the emphasis on protecting individuals from life-threatening extreme weather conditions. Other shelters in Strafford County, such as My Friend's Place in Dover and the Homeless Center for Strafford County in Rochester, operate year-round and have different missions than the

Willand Warming Center, which prioritizes harm reduction-oriented approaches with minimal barriers to access. These differences may include variances in intake processes, background checks, and alcohol and drug testing, among other variables.

Support for the operation of the Willand Warming Center is provided by the cities of Dover, Rochester, Somersworth, and Strafford County as part of a collaborative cold-weather safety plan. Contributions are a combination of operating funds and in-kind services.

The RFP seeks pre-planning and operation of up to 60 beds for the 2023-2024 season.

The Willand Warming Center will open to provide temporary overnight protection at the direction of the Tri-Cities' Emergency Management Directors (EMDs) when extreme winter weather is predicted to pose a significant threat to life safety for unsheltered residents. The Tri-Cities' EMDs will collaboratively determine when the warming center will open, and every effort will be made by the Tri-Cities' EMDs to provide the shelter operator and community partners with a minimum of 24 hours' notice for each request for warming center activation.

The determination to open by the EMDs will be based upon a set of weather conditions pre-determined by the Tri-City Mayors and will be based upon temperature, windchill, precipitation and other weather-related conditions.

Fall leaf collection begins Oct. 30

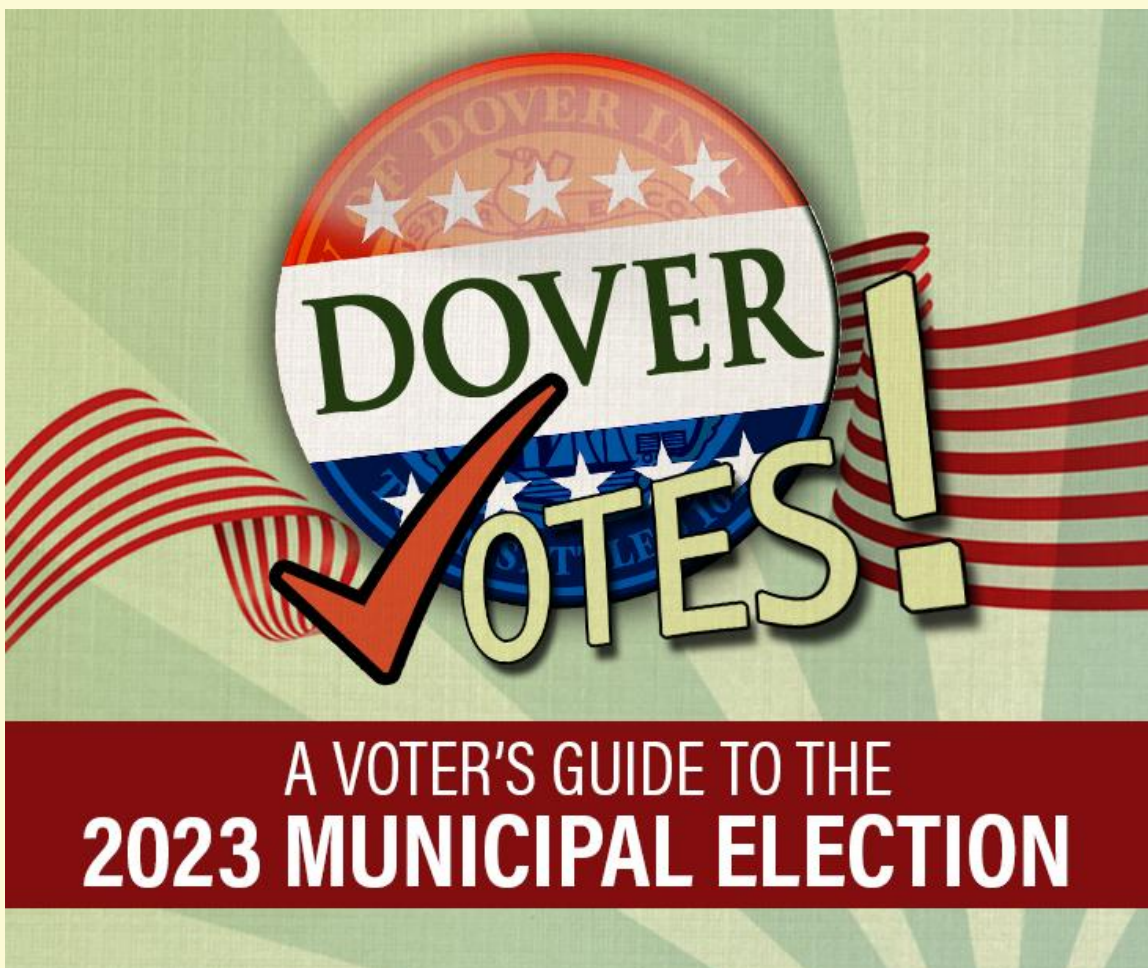
The City of Dover 2023 fall leaf collection will begin Monday, Oct. 30 and continue for six weeks through Dec. 4.

Bagged leaves will be picked up by Waste Management on the same scheduled day as curbside trash and recycling. Please note that pickup is delayed by one day on Thursday, Nov. 23 and Friday, Nov. 24, due to the Thanksgiving holiday.

Leaves must be placed curbside in biodegradable paper leaf bags. No brush will be accepted. Paper bags can be purchased at local hardware or home improvement stores.

Grass clippings, leaves, brush and yard waste are also accepted at the Recycling Center during regular operating hours, Tuesday, Thursday and Saturday, 8:30 a.m. to 3:30 p.m.

candidates' forum before Nov. 7 election

Woodman Museum Hosts 'Voices from the Cemetery' Saturday

Dozens of reincarnated spirits from Dover's past will arise from their graves to entertain, amuse, and recount their lives' achievements (or failures) during the Woodman Museum's "Voices at the Cemetery" fundraiser event Oct. 13 at Pine Hill Cemetery.

The 107-year-old museum will host 40-minute guided walking tours of multiple burial sites where actors portraying notable figures from Dover's history will share tales of mirth, woe, and amazement. Tours leave every 30 minutes from Pine Hill's Ricker Chapel, 131 Central Ave.

Online ticket purchases are strongly encouraged, but walk-ups are welcome on a space-available basis. Tickets are \$20 for adults and \$10 for children. Purchase tickets at www.woodmanmuseum.org or at the museum Wednesday through Sunday from 10 a.m. to 3:30 p.m.

COAST to partially lift service suspensions

The region's public transit system will resume hourly services during weekday mornings and early afternoons on its Route 40, and 43 bus routes beginning on Monday, Oct. 16. COAST was forced to suspend these services on September 1 due to an unexpected wave of unavailability among current staff. The return of several operators and several new bus operators to the COAST team progressing successfully through training has made the return of these services possible.

"We are very happy to resume hourly service for the majority of the service day on these two bus routes during the weekdays," said Rad Nichols, COAST Executive Director. "We will continue to seek to remove additional service suspensions as expeditiously as possible," he added.

Specifics on the changes going into effect on Monday, Oct. 16 include:

- Route 40 in Portsmouth will run hourly between 6 a.m. and 1 p.m. Monday – Friday. Afternoon and evening service will continue to run from 4 to 8 p.m. every other hour.
- Route 43 in Portsmouth and Newington will run hourly between 7 a.m. and 4 p.m. Monday through Friday. Evening service will continue to run from 6 p.m. to 9 p.m. every other hour.

The following events are from various historical records, sources, and texts about the history of Dover.

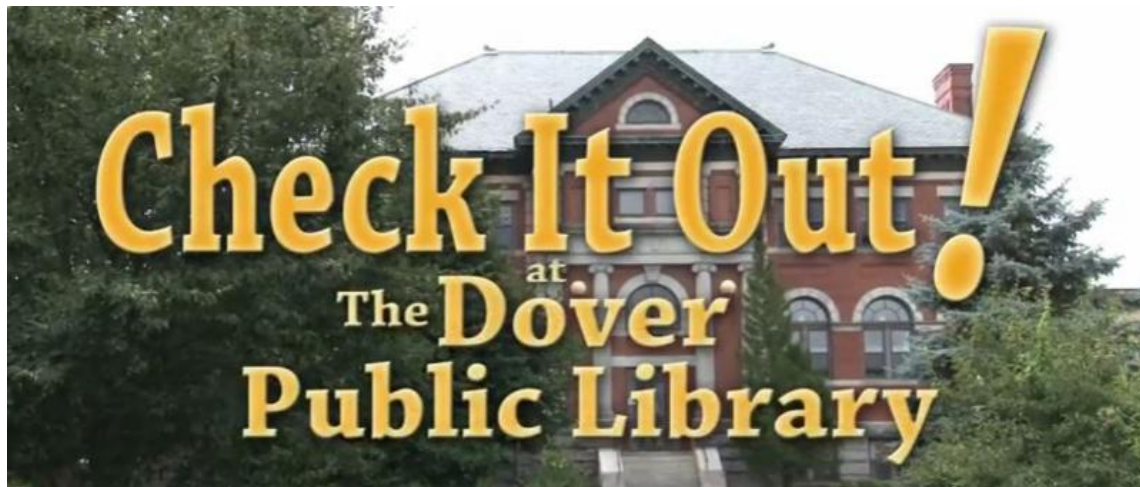
Oct. 19, 1652 — The General Court ordered that the northern bounds of Dover should extend from the first fall of the Newichawannock River (Salmon Falls) upon a north and by west line four miles.

Oct. 19, 1698 — A violent northeast rainstorm melted heavy snow that had fallen during a snowstorm a few days prior, causing significant flooding, carrying away many logs and boards, and endangering Dover's mills.

Oct. 15, 1793 — Many people are now complaining of a distemper arising from an uncommon cold, the effects of which visibly proclaim it a species of influenza, though in operation not so severe nor lasting. (Newspaper account)

Oct. 16, 1840 — Moses Hodgdon, a prominent Dover attorney, died on this day at age 66. He was one of the oldest members of the Strafford Bar, having commenced practice in 1801. He had represented Dover in the Legislature and, at the time of his death, was President of Strafford Bank and of the Savings Bank for the County of Strafford.

Oct. 13, 1999 — Despite opposition from some local restaurants and bars, the City Council on this day, by a vote of 5-3, enacted a smoking ban at local eateries and bars. The new ordinance applied to all bars and taverns that served food without a separately enclosed and ventilated space for smokers. The resolution to ban smoking was the first of its kind in the state. A statewide ban on smoking in bars and restaurants was signed into law in 2007.

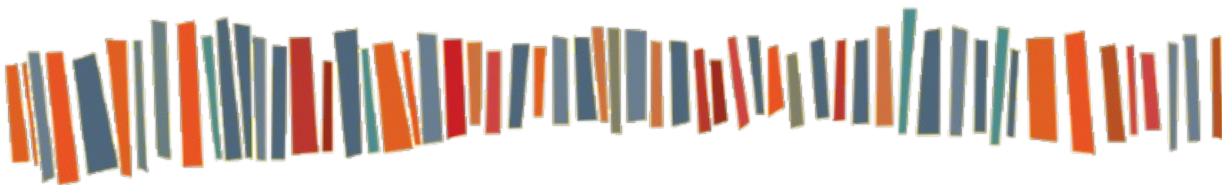

City planners accepting Community Development Block Grant applications

The City of Dover Department of Planning and Community Development is now accepting applications from public service agencies, qualified individuals and eligible organizations for funding through the Community Development Block Grant (CDBG) program. The fiscal year spans July 1, 2024 to June 30, 2025.

Applications are available online at www.dover.nh.gov/government/city-operations/planning/community-development/ and at the Planning and Community Development Department, located at Dover City Hall, 288 Central Ave., Dover, NH 03820. The application submission deadline is 4 p.m. on Friday, Nov. 17, 2023, and must be submitted via email to Dave Carpenter at d.carpenter@dover.nh.gov.

The City of Dover may reject incomplete or late applications.

Eligible CDBG activities include but are not limited to property acquisition, development or improvement of public facilities, clearance or demolition, public services, and special economic development activities.

To be eligible for funding, applicants must meet specific requirements. They include but are not limited to:

- Submission of a complete and timely application.
- Consistent with the FY2021-25 Consolidated Plan.
- Meet one of the following U.S. Department of Housing and Urban Development

(HUD) national objectives:

- Benefit low and moderate-income people;
- Prevention of slums or blight;
- Meet a particularly urgent community development need.

The City of Dover has been a CDBG entitlement community for more than 25 years. The HUD program provides annual grants on a formula basis to entitled cities and counties to develop viable urban communities by providing decent housing and a suitable living environment and by expanding economic opportunities, principally for low- and moderate-income people. HUD awards grants to entitlement community grantees to carry out a wide range of community development activities directed toward revitalizing neighborhoods, economic development, and providing improved community facilities and services. Entitlement communities develop their own programs and funding priorities. The entitlement grant is expected to be available in the summer or fall of 2024. The amount to be received by the City of Dover has yet to be determined by Congress.

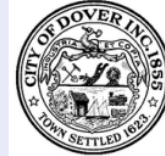
