City Christmas Tree in place at Henry Law Park

Community Services crews this week cut, trimmed and installed this year's Christmas Tree at Henry Law Park, in preparation for the holiday season and the City of Dover's 36th annual Christmas Tree Lighting on Dec. 3.

This year's tree was donated by Herb and Brenda Gingras of Dover. This is the fourth year the Gingras family has provided a tree for Henry Law Park.

Early on Tuesday, Nov. 23, 2021, Community Services crews assembled at the Gingras' Piscataqua Road property to cut down the tree, a 50-foot balsam fir. Once cut and moved with the help of a crane and service donated by Moore's Crane of Dover, the tree was measured, cut to 35 feet, and trimmed before being loaded onto a flatbed truck provided by MacKinnon and Sons Excavating of Somersworth. Once at the park, and again with the help of a crane, the tree was lowered into place and secured in a tree sleeve by Community Services.

In the coming days, the tree will be strung with lights and readied for the annual tree lighting, when the lights will be turned on for the first time. The annual Christmas Tree Lighting in Henry Law Park will begin at 6 p.m. on Friday, Dec. 3, 2021. Nancy Gurick will lead attendees in singing popular Christmas songs around the tree, and will be joined by Seacoast Men of Harmony. Everyone is encouraged to attend this family tradition, held each holiday season, and to bring a weather-appropriate ornament to hang on the tree.

City Council to hold workshop on homeless task force plan

Warming Center opens for winter operations Monday, Nov. 29

The Strafford County Extreme Weather Warming Center (Warming Center) at 30 Willand Drive in Somersworth will open for winter operations at 5 p.m. Monday, Nov. 29, 2021. The Warming Center will be open daily through April 1, 2022.

The hours of operations are Monday through Friday from 5 p.m. to 8 a.m., and all day and night on the weekends, holidays and winter storm days.

The Warming Center is a partnership of the cities of Dover, Somersworth and Rochester and the Community Action Partnership of Strafford County (CAPSC). CAPSC will provide staffing and oversight at the Warming Center through the winter season. CAPSC also seeks community help, including meal donations and volunteering at the Warming Center. Tax rate not yet set by state, delaying the mailing of property tax bills

The New Hampshire Department of Revenue Administration (DRA) has not yet certified the City of Dover's tax rate, delaying the mailing of property tax bills for fiscal year 2022 (tax year 2021).

Finance Director Daniel Lynch said he is waiting for the DRA to schedule an appointment to review financial information provided by the City of Dover so the DRA can certify the tax rate. But the DRA is backlogged due to filing delays from a significant number of other municipalities. DRA officials have told Lynch that these filing delays are from addressing how to report the receipt and use of federal and state COVID-19 grant funding. Although this is not the situation for Dover, it has created a backlog of communities ahead of Dover in the tax-rate setting queue.

Once the DRA certifies the tax rate, tax bills will be printed and mailed to property owners. The due date for the first half of the tax bill will be one month from when the tax bills are mailed; the second half will be due on June 1, 2022.

Last year, the DRA did not set the tax rate until Dec. 3, 2020, due to the impacts of the COVID-19 pandemic. Because of the late tax-rate setting, the City Council authorized a tax anticipation note (TAN). The TAN allowed short-term borrowing by the City of Dover to make two significant

annual payments due in mid-December while waiting to receive property tax payments: One to the Strafford County government and the other for debt service. Lynch does not anticipate the need for the City Council to authorize a TAN for this year.

Waterfront project under review by Technical Review Committee

Park Subcommittee contemplating paddle sport facility options

Cochecho Waterfront Development Advisory Committee (CWDAC) Chair Dana Lynch provided the City Council a status update of the long-planned redevelopment of city-owned River Street land at a recent meeting.

The update provided the public with new renderings of the project under review by the Technical Review Committee (TRC). Lynch's presentation also included renderings of the entrance to the public Cochecho River Waterfront Park, part of the City of Dover's responsibility as part of the overall land disposition agreement between developer Cathartes and the city. Lynch provided the update during the City Manager's Report portion of the Nov. 10 City Council meeting, which can be viewed in its entirety here:

CWDAC provided conditional approval to Cathartes' site plan at its Aug. 31 meeting, allowing Cathartes to submit plans to be TRC. Once it clears the TRC, the project will move to the Planning Board for final approval. Cathartes' development plans for Dover's former wastewater treatment plant and public works garage include building 413 residential units, including apartments and townhouses, and 30,000 feet of commercial space.

Part of CWDAC's approval included the condition for Cathartes, the City of Dover's planning and recreation staff, and the CWDAC's Park Planning Subcommittee to "work diligently and closely with the paddlesports community to ensure cooperation in any future plans for the design, permitting and construction for a paddle sports facility."

The Park Subcommittee has been meeting with stakeholders to finalize plans for the waterfront

park and come to a consensus on what's needed for a paddle sports facility. The subcommittee last met on Nov. 3, 2021, where it reviewed options for crew boat storage at the waterfront park. Currently, the metal "Butler Building" at the Cochecho River's edge is utilized by Great Bay Rowing, Berwick Academy, University of New Hampshire and Northeast Passage. However, the building is set to be removed as part of the waterfront development.

The crew boat building options that the subcommittee are considering includes a first-floor space in one of the Cathartes buildings, utilizing the planned pavilion building at the waterfront park, or potentially expanding the pavilion building and constructing a freestanding boat building elsewhere in the park. The latter options would require additional permits from the New Hampshire Department of Environmental Services.

The subcommittee has not made any recommendations for crew boat storage and is still seeking information on the number of people and boats used and when they are used. The subcommittee meets next on Wednesday, Dec. 1. Any recommendations made by the subcommittee would be brought to CWDAC for a final decision.

Contractor continues individual connections to new Central Avenue water main

Next week, the Central Avenue North Water Improvements project contractor will continue connecting individual water users to the newly installed water main. The contractor will be working at different spots along Central Avenue, requiring detours at some locations and one-lane traffic alternated by flaggers in others.

On Monday, Nov. 29 and Tuesday, Nov. 30, the contractor plans to work on Central Avenue between Abbey Sawyer Memorial Drive and Lowell Avenue. Southbound Central Avenue traffic will be detoured around the project area via Lowell Avenue, Mount Vernon Street and Ash Street. Northbound traffic will proceed through the project area. Motorists should anticipate lane shifts.

Wednesday, Dec. 1 and Thursday, Dec. 2, the contractor will be working on Central Avenue between Lowell Avenue and Glenwood Avenue. Traffic will be restricted to one lane through the project area, alternated by flaggers.

Friday, Dec. 3, the contractor will pave the week's work area. Motorists should anticipate traffic being restricted to one lane, alternated by flaggers, or the southbound detour via Lowell Avenue, Mount Vernon Street and Ash Street.

Community Services Director Bill Boulanger is reaching out to residents and businesses to schedule water connections. 

Dover Fire & Rescue vaccinate nearly 500 children at school clinics

Last week, Dover Fire & Rescue teamed up with middle and elementary school administrators and staff to administer COVID-19 vaccines to eligible students ages 5 to 11, with parent or guardian permission.

"This is part of our continuing effort to vaccinate our community as efficiently as possible and help return people's lives back to normal," said Fire Chief Paul Haas. "As soon as the approval for the 5 to 11 age group was imminent, we immediately met with Dover School District administrators to begin planning this effort."

In late October, the Dover School District began to survey parents and guardians to gauge interest in a vaccination clinic. Parents and guardians who were interested then signed permission slips to authorize Fire & Rescue paramedics and emergency medical technicians to provide vaccine shots to their children at school-based clinics. From Tuesday, Nov. 16 through Friday, Nov. 19, Fire & Rescue personnel administered vaccines to nearly 500 students across the district's middle and elementary schools.

"The widespread participation by parents and kids who chose to take advantage of the opportunity to get vaccinated clearly shows the eagerness people have to protect themselves and their families from Covid-19 and to return our community to a greater sense of normalcy," Haas said. "The only way we will get there is through vaccinating against this virus.

"As with any other vaccination that children regularly receive from their doctors, we had kids who were eager, kids who were nervous, and kids who were indifferent to the prospect of getting a shot," Haas said. "At the end of the day, there were no surprises. About 95% of the vaccinated kids were in school the next day, ready to go. Some chose to stay home in case they didn't feel well, but we are not aware of anyone who had any significant symptoms related to the vaccine."

Haas urges community members who have not yet been vaccinated to do so. Vaccines are

currently available at many pharmacies locally, either by appointment or walk-in.

All students will receive their second vaccination in three weeks through a similar effort.

CDC expands adult eligibility for booster shots

People age 18 years and older who received Pfizer-BioNTech or Moderna COVID-19 vaccines may get a booster six months after completion of their primary vaccination series.

Contact the location that set up your previous appointment. If you need to find a different location, there are several ways you can <u>find a vaccine provider</u>.

You may choose which COVID-19 vaccine you receive as a booster shot. Some people may prefer the vaccine type that they originally received, and others may prefer to get a different booster. CDC's recommendations now allow for this type of mix and match dosing for booster shots.

COVID symptoms or need to confirm you aren't infected? Get tested

Many health insurance plans cover COVID-19 tests without a copay, coinsurance, or deductible for persons with symptoms of COVID-19. Locations throughout the state offer COVID-19 tests, including hospitals, pharmacies, primary care offices, urgent care centers.

Tests for active COVID-19 disease are available in locations across New Hampshire and include both the polymerase chain reaction (PCR) test and the rapid antigen test. The PCR test is for persons with or without symptoms of COVID-19. The rapid antigen test is for persons with symptoms and within a specific timeframe after onset of symptoms.

The federal government has contracted with Walgreens and Rite Aid pharmacies to offer COVID-19 tests at no additional costs for persons without insurance with symptoms of COVID-19. Visit the website of these pharmacies or contact your local Walgreens or Rite Aid pharmacy to learn more about their free testing program.

Persons who do not have insurance or have a health insurance plan that does not fully cover the cost of tests may also have testing paid for by a New Hampshire Limited COVID-19 Testing Benefit. The following events are recorded in "Notable Events in the History of Dover, New Hampshire: From the First Settlement in 1623 to 1865," by George Wadleigh, and several other historical sources.

For more on the history of Dover, settled in 1623 and the oldest European permanent settlement in New Hampshire and seventh oldest in the country, visit the Dover Public Library, Locust Street; and the Woodman Museum, Central Avenue. The Public Library also maintains an online collection of historical information, <u>located here</u>.

Nov. 27, 1758 — The selectmen were directed to take care of the old meeting house "so that it may not be exposed to be torn to pieces this winter."

Nov. 30, 1847 — The Strafford Bank moved from its old location near the Dover Hotel to Central Square.

Nov. 27, 1852 — The shock of an earthquake was distinctly felt, resembling the rattling of carriage wheels on frozen ground.

Nov. 26, 1855 — Elections for Ward Officers under the new city charter were held on Monday and Tuesday of this week.

Dec. 1, 1999 — At a ceremony on this day, the Dover Housing Authority dedicated its community center as the Seymour Osman Community Center, naming it after the longtime supporter of a variety of social programs at DHA. Osman spoke at the ceremony, which was attended by more than 100 people. Osman, who moved to Dover in 1945, was president of United Tanners from 1963 until his retirement in 1978. He was involved with numerous civic and nonprofit organizations, including the United Way, Heart Fund, Little League and Temple Israel. Osman's received Rotary's Paul Harris medal for his work with the underprivileged, and the Greater Dover Chamber of Commerce's 1991 Citizen of the Year. Osman also helped form the Dover Business and Industrial Development Authority and was a member of the Wentworth-Douglass Hospital Board of Trustees. Osman died in 2006.



Dover400 merchandise makes great holiday gifts



Be prepared, sign-up for parking ban alerts

Parking Manager Bill Simons reminds City of Dover drivers to sign-up for parking ban alerts ahead of the upcoming winter season.

Users can receive text and/or email alerts if a winter parking ban is declared, which requires the removal of all vehicles from public ways to allow street and sidewalk plowing. To receive text alerts, visit https://bit.ly/dovercodered, or text "DoverNH" to 99411 from your phone. To receive email alerts, visit https://bit.ly/doverdownload.

'As-needed' winter parking bans

During winter storm events or post-storm cleanups, the Community Services Director may

declare a winter parking ban to allow crews to clear roads efficiently. When a parking ban is declared, all vehicles must be off public ways by the time the ban goes into effect. If vehicles are not removed, they may be ticketed and/or towed.

Most residents know not to park on the roads when there is an active storm. "People get it," said Parking Manager Bill Simons.

However, Community Services struggles with compliance with parking bans for post-storm cleanups when crews remove high snow banks or push snow back, so streets and sidewalks are passable and ready for the next storm.

"Ninety-five percent of parking tickets for winter parking ban violations come on cleanup nights," Simons said. "The goal is not to give out any tickets or have any cars towed and let Community Services do their job."

A parking ticket is \$50. A tow is likely to be above \$150.

Unless a parking ban is declared, vehicles may be parked on the street except for areas covered by the seasonal winter parking restrictions.

When a winter parking is declared

A parking ban will be declared by 3 p.m. to begin at a designated time later that evening. When a ban is declared, parking is prohibited on city streets, sidewalks and adjacent parking areas, such as the angled spaces on School or First streets. Vehicles must be parked on private property, at an authorized public parking lot, or the parking garage. Vehicles that violate the parking ban may be ticketed and towed at the vehicle owner's expense.

Apartment building owners are encouraged to alert all tenants about announced parking bans.

The parking ban for the downtown area typically starts later than all other parts of the city. <u>Click</u> <u>here</u> for the downtown parking ban map.

Many options to receive parking ban notifications

The City of Dover utilizes its website, social media accounts, Channel 22, text and email alerts, and press releases to local news media to notify residents about parking bans. The current ban status is always posted at https://www.dover.nh.gov/government/city-operations/police/parking-bureau/parking-bans.html. People can also call 603-516-PARK (7275) to check the parking ban status.

For email notifications, visit https://bit.ly/dovernewsletters and select the "Parking Ban Alerts" option. For text-based notifications via the City of Dover's emergency notification system, CodeRED, sign-up by texting "DoverNH" to 99411. Please note that cellular phone carrier and/or text message fees may apply.

Text alerts are also available by creating an account and logging into the city's emergency notification system, <u>CodeRED</u>. After creating an account, select the option for Parking Ban Notifications under "Additional Notifications." Users must provide a phone number capable of receiving text alerts. Cellular phone carrier and/or text message fees may apply.

Users should receive a confirmation email or text after a successful sign-up. If not, call the City of Dover's Media Services at 603-516-1641 for assistance.

Where to park during a parking ban?

Some public parking lots have areas available for overnight parking. Click here to view a map of municipal parking lot locations in the downtown area. The Orchard Street Parking Garage has limited short-term spaces and is for "Permit Parking Only" above the second floor (look for signs). Overnight parking is available in spaces 101-278 for \$1/hr. Paid parking in the garage is 24/7, including holidays. Users may pay for parking or extend parking time through the smartphone "Flowbird parking" application. Users must know the number of the space where the vehicle is parked.

Seasonal winter parking restrictions

In addition to winter parking bans that can be called at any time, there are several streets where seasonal winter parking restrictions are in place from Dec. 1 to April 1, regardless of the current weather conditions. These streets, listed below, do not allow parking at any time, day or night, between Dec. 1 and April 1.

The following streets are included in the seasonal winter parking restrictions:

- Baker Street, no parking on northerly side (odd numbered)
- Belknap Street, no parking on the westerly side (odd numbered), from Washington Street to Silver Street
- Belknap Street, no parking on the easterly side (even numbered), from Silver Street to Fisher Street
- Cushing Street, no parking on the easterly side (even numbered)
- Everett Street, no parking on the westerly side (odd numbered)
- Elm Street, no parking on the westerly side (odd numbered)
- Essex Street, no parking on the southwesterly side (even numbered)
- Everett Street, no parking on the westerly side (odd numbered)
- Fifth Street, no parking on the northerly side (odd numbered), from Chestnut Street to Grove Street
- Fifth Street, no parking on the southerly side (even numbered), between Grove Street and Tammany Park
- Folsom Street, no parking on the southerly side (even numbered)
- Forest Street, no parking on the northwesterly side (even numbered)
- Fourth Street, no parking on the southerly side (even numbered), from Chestnut Street to Grove Street
- Hamilton Street, no parking on the northerly side (odd numbered)
- Hancock Street, no parking on the southwesterly side (even numbered)
- High Ridge Drive, no parking on southerly side
- Lexington Street, no parking on the easterly side (even numbered)
- Lincoln Street, no parking on the southerly side (even numbered), from Chestnut Street to Grove Street
- Nelson Street, no parking on the southerly side (even numbered), from Locust Street to Atkinson Street
- Plaza Drive, no parking on easterly side (even numbered), from Norway Circle northerly to end of street
- Richmond Street, no parking on the westerly side (odd numbered)
- Rogers Street, no parking on the southwesterly side (even numbered)
- Saint Thomas Street, no parking on the northerly side (odd numbered), from Atkinson Street to Belknap Street, and two spaces in front of 33/35 Saint Thomas Street
- Summer Street, no parking on the southerly side (even numbered)
- Third Street, no parking on the southerly side (even numbered), from Chestnut Street to Grove Street
- West Concord Street, no parking on the northerly side (odd numbered)
- Young Street, no parking on the southerly side.

When a parking ban is declared, both sides of the listed streets are restricted, as are all other city streets.

Help prevent bear-human conflict as bears prepare for winter hibernation

The New Hampshire Fish and Game Department is asking residents not to rush the arrival of bird-feeding season this fall. The Granite State's bear population is actively preparing for their denning period and on the move in search of high-fat, protein-rich food sources to sustain them through the winter. As a result, bears in some areas are turning to residential areas for food, and Officials are asking the public to be both proactive and responsible by holding off on putting out bird feeders until December. Increasingly mild autumns and the often-late arrival of winter conditions warrant adjustments to prevent human-bear conflicts.

"Reports of conflicts between bears and people were lower during the summer this year, but there has been an uptick in bear activity and sightings, most of which occurred at bird feeders, during late October and early November," said Andy Timmins, Fish and Game's Bear Project Leader. "By taking action now, you can prevent attracting a hungry bear to your home this fall.

Do not wait for a bear to raid the bird feeder or feed from a dumpster and then respond. Doing so encourages foraging behavior by bears near residences. A single food reward will cause the bear to return and continue to search the area for food, no matter the season. Averting conflicts with bears requires increased responsibility and proactive behavior by the public. Bears have an excellent sense of smell and good memories."

Despite continued pleas asking homeowners not to feed birds during the non-winter months, bird feeders typically are the direct cause of 25% of annual bear-human conflicts. In addition to bird feeders, other attractants that contribute significantly to conflicts include unprotected chickens and other poultry (23%) and unsecured garbage cans/dumpsters (38%).

"If the public would be willing to address these three common attractants, we could quickly reduce annual bear-human conflicts by 70-80%, which would be a tremendous benefit to New Hampshire's bear population," said Timmins.

Avoid encounters with bears by taking a few simple precautions:

- Birdfeeders should not be put out until December 1 or once bear activity slows, whichever comes later. Bringing birdfeeders in at night is not sufficient.
- Stop all bird feeding by April 1 or at the onset of extended spring-like weather conditions, whichever comes first.
- Clean up any spilled birdseed and dispose of it in a secured trash container.
- Store all garbage in airtight containers inside a garage or adequate storage area, and put garbage out on the morning of pickup, not the night before. If using a dumpster, inform your dumpster company that you need a dumpster with metal locking tops and doors that are inaccessible to bears and other wildlife.
- Avoid putting meat or other food scraps in your compost pile.
- Do not leave pet food dishes outside overnight.
- Clean and store outdoor grills after each use.
- Never deliberately feed bears.

These steps will help to ensure that your backyard does not become attractive to bears and other wildlife, which is important because it prevents property damage by bears and keeps bears from becoming nuisance animals.
