Coming up at the next City Council meeting

### **City Council set to authorize bonding for public/private partnership**

#### **Extending Housing Committee, establishing DHS scholarship also on agenda**

The City Council will consider a resolution authorizing \$2 million in bonding for public improvements related to the Terra Nova/Westfield Land Development Agreement at its Wednesday, Aug. 28 meeting. The Council held a public hearing on the resolution at its Aug. 14 meeting.

In 2022, the City Council authorized the city to enter into a public-private partnership in developing two parcels adjacent to Littleworth Road – one owned by Terra Nova LLC and the other by Westfield LLC. The agreement calls for the city to reimburse the developer for public improvements costs, which include utilities and a street connection between Crosby Road and Industrial Park Drive. Per the agreement, which allows for a multi-year, multi-phase project, the city will not reimburse for the public improvements until each development phase is complete and generating property taxes. The first phase included the development of Bluebird

Self Storage, which has an estimated taxable value exceeding the amount needed to service the \$2 million bond.

The City Council will also consider extending the duration of its ad hoc Committee to Address Community Housing Needs. The committee was charged to submit a final report to the Council by September's end; however, due to the extension of grant programs supporting its efforts, the committee has requested to extend its deadline to Jan. 31, 2025.

Following the School Board's vote on Monday, the City Council will consider establishing the Walter and Pauline Calderwood Memorial Scholarship Fund at the bequest of Pauline Calderwood. Her family were residents of Dover and had children who graduated from Dover High School. In her trust, she bequest \$505,000 to establish a Dover High School scholarship.

At the beginning of the meeting, Mayor Robert Carrier will also proclaim the week of Sept. 17 as Constitution Week to honor the drafting of U.S. Constitution in 1787. Carrier will also proclaim September National Service Dog Month in Dover.

## City Council to receive recommendations on curbside waste, recycling collection future at Sept. 4 workshop

### Current contract ends June 30, 2025

The future of the city's curbside trash and recycling collection and disposal will be the topic of an upcoming City Council workshop on Wednesday, Sept. 4.

At the workshop, the Solid Waste Advisory Committee (SWAC) will present its findings and recommendations to the City Council on how the city should proceed at the end of its current curbside collection and disposal contract. The city's five-year contract with Waste Management, Inc., expires at the end of the 2025 fiscal year on June 30, 2025.

At its Aug. 7 meeting following months of review, SWAC unanimously endorsed multiple recommendations to present to the City Council: continue the practice of contracting out curbside collection; switch to a toter system and phase out the current pay-as-you-throw bags; and utilize the utility model to fund collection and disposal costs. SWAC also endorsed extending the city's contract with Waste Management for seven years after receiving a proposal at its July meeting.

Since July 2022, SWAC members have been investigating future collection options, including whether the city should take over curbside collection instead of contracting it out as the city once did and as Portsmouth and Durham do now. City Manager J. Michael Joyal, Jr. asked the committee to study the issue, stating the city faces fewer competitive contractors willing to bid on the service. When the collection and disposal service was last put out to bid in 2019, there were fewer bidders than expected, and the lowest bid added a million more per year in disposal costs than the previous contract: a \$400,000 increase

in solid waste and \$600,000 in recycling disposal costs.

At the recommendation of SWAC, the city sought an outside expert consultant to review industry trends and provide a cost analysis and recommendations through a feasibility study. Conducted in 2023, the consultant presented the study's final report to the Council in January. The report recommended retiring the PAYT bags in favor of a toter system – one for trash and one for recycling. Toters allow for collection utilizing trucks with manual loading arms, which the industry is moving towards as it reduces labor costs and improves worker safety. The consultant also recommended the city take over curbside collection through purchasing or leasing vehicles.

Following the report, the City Council tasked the SWAC to review the consultant's findings and make recommendations to the City Council on how to proceed at the contract's end. At SWAC's recommendation, the Council also authorized the City Manager to negotiate a contract extension with Waste Management for the City Council's consideration, allowing the city time to build out the infrastructure of a curbside program and/or implement a toter system if needed. To assist SWAC's decision-making progress, the committee created an ad hoc committee that met frequently to study the issue, updating SWAC regularly.

At SWAC's July 18 meeting, Waste Management presented a two-year extension proposal with an option to extend it an additional five years with a conversion to toters; the proposal's pricing will hold through the end of the 2024 calendar year. The first two years of the extension continue the current PAYT model.

SWAC endorsed utilizing the utility model to offset the revenue loss caused by ending the PAYT model. Currently, solid waste and collection costs are funded through the PAYT system; recycling collection is funded through the general fund. One concern of SWAC is ensuring the city's curbside collection pricing is competitive with private haulers.

The workshop will be held in Council Chambers at City Hall, beginning at 7 p.m., on Sept. 4.

## **Dover's public schools gear up for new school year**

The Dover School District is preparing for the first day of school on Tuesday, Sept. 3. Dr. William Harbron, Superintendent of Schools, has announced the following events and activities surrounding the start of the 2024–2025 academic school year.

### **Immunization**

New Hampshire law states that no student may be admitted to a public school unless proof of immunization has been presented prior to their entrance. Parents of new students should be prepared to present a copy of immunization records before the opening day of school.



## 2024–2025 Re-entry Plan

On Aug. 19, the Dover School Board approved the [2024-2025 Re-Entry Plan](#). The New Hampshire Education Department requires this plan while receiving ESSER funds. ESSER (Elementary and Secondary School Emergency Relief) funds are federal emergency grants provided to schools to address the impact of COVID-19.

### Transportation

For students to be eligible for bus transportation, elementary students (including kindergarten), must live a distance of one mile or more from their school; middle school students, at least one and one-half miles from school; and high school students, at least two miles from school. The [bus routes and schedule information](#) have been posted on the district website, at each school, and at the office of the Superintendent. You may also call the bus provider First Student Transportation at (603) 692-4406. Parents of students who receive special education transportation services within Dover should call Seacoast Learning Collaborative (SLC) at (603) 679-2021 with questions. Parents with questions regarding other special busing arrangements should call the Student Services Department at (603) 516-6722.

### District-wide

On Tuesday, Aug. 27, school and district offices will be closed from 7:30–9 a.m., to allow staff to attend a district-wide conference. On Thursday, Aug. 29, school and district offices will be closed from 1–3:15 p.m. to allow staff to attend a mandatory training session.

### Elementary Schools

On Thursday, Aug. 29, Kindergarten students will have orientation from 9 to 11 a.m. Each elementary school will send detailed information to families.

On Tuesday, Sept. 3, elementary schools will open at 8:05 a.m. and dismiss at 3:05 p.m.

### Dover Middle School

On Thursday, Aug. 29, fifth-grade students will have an orientation from 8:30 to 10:30 a.m., and buses will run their normal routes.

On Tuesday, Sept. 3, all middle school students will begin a full school day. Middle school doors will open at 7:10 a.m., and school will begin at 7:30 a.m. Students who have not been assigned a homeroom should report directly to the Guidance Office upon arrival. Students will be dismissed at 2:20 p.m.

All middle school students can view their teacher assignments through the Infinite Campus parent portal.

New student registration is completed through the district website. Registration requirements include a copy of the student's birth certificate, immunization record, proof of a medical physical dated August 30, 2023, or after (or details of an upcoming appointment with the date and time, to be conditionally enrolled), and proof of Dover residency (ex. Utility bill or signed copy of lease). Students entering grades seven and eight will not be enrolled without an updated rubella immunization. ## **Dover to host Household Hazardous Waste Day Saturday**

The City of Dover, along with the towns of Rollinsford, Lee and Madbury, will hold a Hazardous Waste Collection Day on Saturday, Aug. 24, 2024, from 8:30 a.m. to 12:30 p.m., at the City's Community Services facility, 271 Mast Road.

The goal of Hazardous Waste Collection Day is to allow for the proper disposal of household hazardous materials. Residents of the four communities can bring household hazardous waste to Community Services for safe disposal.

The following household waste will be accepted: fertilizer with acids; bathroom cleaners; brush cleaner; pesticides; car waxes/polish; disinfectants; corrosives; fungicides; creosote; furniture polish paint/stain/finish; insect spray; driveway sealers/tar; metal polish (lead and oil-based); lighter fluid; flea powder; mothballs; rust preventatives; pest strips/traps; gasoline; oven cleaners; solvents; pesticides; radiator flush; photo chemicals; thinner/turpentine; poisons; roofing tar; rug cleaner; wood preservatives; pool chemicals; and wood strippers. Empty containers are not hazardous. Please dispose of them in your regular trash.

Explosives, asbestos, batteries, fluorescent bulbs, propane tanks, latex paint, waste oil and antifreeze will not be accepted.

Hazardous Waste Collection Day is for residents only. Proof of residency is required.

## Dover Utilities Commission seeks members

The Dover Utilities Commission seeks two Dover citizens to join its ranks. Members appointed to the DUC serve three-year terms, meeting monthly, unless circumstances require more frequent meetings.

DUC recommends general policies for the water and sewer functions of the Community Services Department. They also make recommendations regarding the development, maintenance, operation and expansion of the water supply system in the city. In addition, the DUC advises the city on policy, rate structure, public relations and matters of general public interest. The DUC is also tasked with hearing and deciding abatement appeals.

The DUC also has the authority to formulate public water and sewer system rules in the city, subject to the review and approval of the City Council. Annually, the DUC reviews water and sewer charges and recommends any revisions necessary to reflect actual operation and maintenance costs.

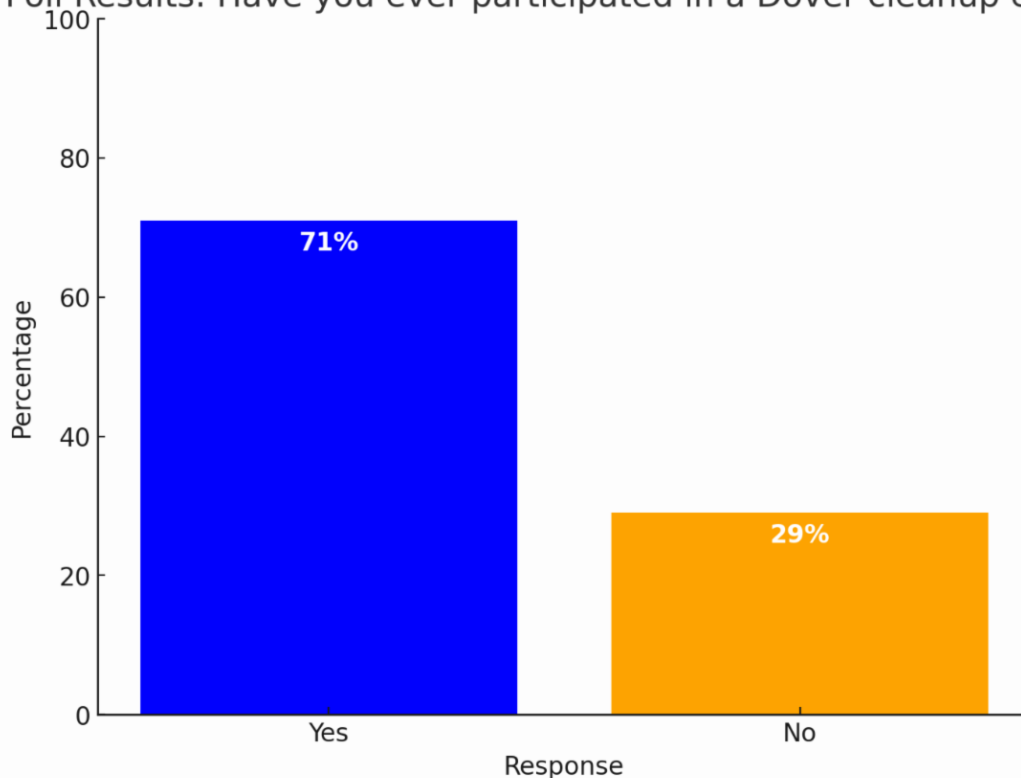

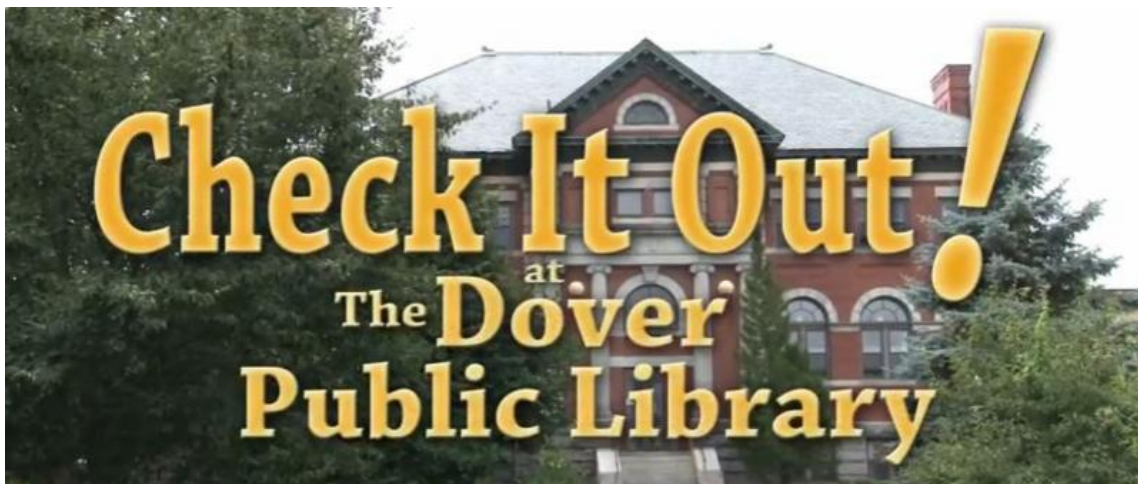
**Aug. 28, 1797** — The town voted to allow Dr. Jacob Kittredge to open a hospital to inoculate for the small pox, and that the selectmen, with Dr. Ezra Green and William Hale be a committee to find a location for the hospital and decide when it should be opened and closed.

**Aug. 29, 1814** — The town created a committee led by Daniel Durell to investigate the state of the town's public lands and determine if anyone had illegally taken over parts of them. The committee discovered that some nearby landowners had fenced off roads and other common lands that originally belonged to the town, somehow including these areas in their private properties. While the town accepted the committee's report, it doesn't seem that any further action was taken to address the issue.

**Aug. 29, 1842** — The remains of two skeletons believed to be Native Americans were found when digging where Orchard Street meets Central Avenue, near which was also the site of Peter Coffin's garrison house in 1689.

**Aug. 25, 1846** — An earthquake rocks the region. To many people, it sounded like the departure of a heavy train of railroad cars, for which it was mistaken by many at the time.

**Aug. 23, 1886** — Michael Clarity of Dover died on this day. Clarity was originally from Ireland and was involved in a rebellion in the north of Ireland in 1837. As a consequence of his participation in the uprising, he was arrested by the British government and sentenced to 20 years at Van Diemen's Land, a penal colony in what is now Tasmania, Australia. He served 14 years of this sentence before being pardoned. After his pardon, Clarity returned to Ireland and eventually emigrated to America in 1855, settling in Dover.

## **Guide to Sept. 10 state primary election**

The state primary election will be held on Tuesday, Sept. 10, 2024. Polling hours in Dover will be from 7 a.m. to 7 p.m.

The election will determine political party nominees for the general election to be held on Tuesday, Nov. 5, 2024. There are two ballots for the Sept. 10 primary election: one for registered Republicans and one for registered Democrats. Undeclared voters may declare a party at their polling location on Election Day and receive that party's ballot. Voters may change party status back to undeclared by signing a form at the polls following the vote.

## **Dover Adventure Playground to close for two weeks next month**

The Dover Adventure Playground at Henry Law Park will be closed for two weeks for maintenance beginning Monday, Sept. 9. ## New Hampshire hunting seasons open Sept. 1

New Hampshire's fall hunting seasons kick off on Sunday, Sept. 1, with the opening of black bear and gray squirrel seasons. Archery seasons for turkey and white-tailed deer get underway Sept. 15, and the statewide resident Canada goose hunt runs Sept. 1–25.

Apprentice hunting licenses are an option for people age 16 and older who want to try hunting but have not taken Hunter Education or who have not been able to schedule a field day. The apprentice hunting license allows unlicensed people to hunt under the guidance of a licensed hunter age 18 or older. Apprentice licenses are available only at NH Fish and Game Headquarters, 11 Hazen Drive, Concord.

As the fall hunting seasons begin, the NH Fish and Game Department asks hunters not to use natural urine-based deer lures. These products can potentially spread chronic wasting disease (CWD), a neurological disorder that is always fatal to white-tailed deer and moose. Synthetic lures are suggested.

Hunters should remember to take proper care when handling wild game to minimize possible exposure to wildlife diseases. First and foremost, hunters should avoid shooting or handling any animal that appears sick.
