City implements mandatory water use restrictions

Effective Monday, Aug. 22, the City of Dover issued a mandatory, citywide ban on outdoor water use to ensure an adequate and sustainable water supply throughout the city into the fall and winter months.

Drought conditions in Dover and southern Strafford County continue to be severe, prompting the New Hampshire Department of Environmental Services to urge affected communities to invoke mandatory water restrictions. With drought conditions persisting, along with the Pudding Hill aquifer offline, City Manager J. Michael Joyal, Jr. issued an emergency order on Aug. 22, enabling water restrictions on nonessential outdoor water use, per City Ordinance 121-51.

"At this time, we cannot predict how long the outdoor water ban will remain, but it is likely to extend into the early fall when we should see more regular beneficial precipitation," Joyal said.

The order comes after consultation with the city's contracted hydrogeologists tasked with monitoring the city's aquifer levels. They've noted that Dover has recorded as much as 11 inches of precipitation below average this year. While rain this week was

Tuesday, Thursday, Saturday: 8:30 a.m. to 3:30 p.m. helpful, the season's precipitation deficit remains significant.

The U.S. Drought Monitor has classified Dover as being in a severe drought since the beginning of the month. Moderate drought conditions persisted in July, and abnormally dry conditions emerged mid-May.

Outdoor water restrictions

Under the emergency order, the following outdoor water use restrictions are in place:

- No outside lawn watering or irrigation, including automatic sprinklers, automatic irrigation; systems, and no unattended lawn watering;
- No washing of vehicles, including automobiles, trailers and trucks;
- No filling of swimming pools of 100 gallons or greater.

Hand watering of gardens and new plantings is allowed. Commercial car washes, agriculture operations, flower shops and garden centers are not affected by the restrictions at this time.

Water conservation efforts by all water users, including well users, will reduce the demands on Dover's water supplies, reduce stress on water resources, and ensure sufficient water is available to meet all customer and emergency operation needs, such as fire supply. The emergency order will be enforced by public outreach, followed by warnings to those in violation, and fines of up to \$250 per violation, if necessary. 
In addition to the mandatory water restrictions outdoors, there are several other ways users can help conserve water, including:

- Cutting back on shower times, only doing full loads of laundry when necessary, and turning off the faucet while brushing teeth, doing dishes and washing hands.
- Replace old water fixtures and appliances that are wasting water. Top-loading washing machines built before 2003 and toilets older than 1994 are known to be the largest water-wasting culprits in the home. Showerheads older than 1994 can also waste a great deal of water, as can older bathroom sink aerators. Selecting ENERGY STAR certified machines and replacing old water fixtures with EPA WaterSense certified fixtures is an easy way to ensure you are choosing products that will save water and perform. - Fix leaks, including running toilets. Running toilets can waste hundreds of gallons a day. Old and worn toilet flappers are often the culprit and are very easy to replace. Also, some toilet leaks can't be heard. Check for a leak by dropping food coloring (12 drops) or a leak detector dye tablet in the toilet tank. Do not flush for 15 or 20 minutes. If the dye shows up in the bowl, you know that your toilet is running.

Community Services seeks to replace remaining older water meters

Meter change out quick; workers can accommodate different schedules

Community Services has replaced nearly all older water meters that have exceeded their life expectancy. The new water meters will help improve billing cycles and timeliness of billings. These water meters also track hourly use, aiding homeowners with leak detection. More than 8,200 new water meters have been installed since the program started a few years ago.

There are still a few hundred of the older water meters that need to be changed out despite multiple attempts by city workers to schedule a water meter change out. Soon, these residents will be notified that if they don't have their water meter changed, their water service will be turned off and remain so until the new water meters are installed.

Changing out water meters is quick, usually taking about 30 minutes or less to complete. City workers are willing to come to do the swap out at a time convenient for the homeowner.

Deadline to order bricks for Veterans Park to be installed by Veterans Day is Aug. 31

The Recreation Department will order another round of engraved bricks for Dover Veterans Park to be added for Veterans Day on Nov. 11. The deadline to have bricks included in that order is Wednesday, Aug. 31, at 4 p.m.

Orders collected after the deadline through Feb. 28, 2023, will be sent in the next batch to be installed in the park by Memorial Day. The cost is \$100 for an 8-inch by 8-inch brick and \$50 for a 4-inch by 8-inch brick. The only requirement to



have a name engraved is for the person to be a veteran. All bricks are engraved consistently with a full name, military rank and branch, and years of service and/or conflict. Upon request, bricks may also be grouped by family or service time.

The Dover Veterans Park was dedicated four years ago in 2017 on Veterans Day and now has about 900 bricks honoring veterans.



Message from the Superintendent

Schools Superintendent William Harbron released additional information this week about the new school year, including details about school transportation.

According to the announcement, "In order for students to be eligible for bus transportation, elementary students (including kindergarten), must live a distance of one mile or more from their school; middle school students, at least one and one-half miles from school; and high school students, at least two miles from school. The bus routes and schedule information have been posted on our website. You can view them by clicking here (www.dover.k12.nh.us), on our Facebook page at https://www.facebook.com/DoverNHSchoolDistrict/, as well as in each of the schools, the office of the Superintendent, or by calling the bus provider First Student at (603) 692-4406. Parents of students who receive special education transportation services within Dover should call the bus company Seacoast Learning Collaborative (SLC) at (603) 679-2021 with any questions. Parents with questions regarding other special busing arrangements should call the Special Education office directly at (603) 516-6722."

Harbron also explained how new student registration works. The process is completed through the <u>school district's website</u>. Registration requirements include a copy of the student's birth certificate, immunization record, proof of a medical physical dated Aug. 30, 2021 or after (or details of an upcoming appointment with the date and time, to be conditionally enrolled), and proof of Dover residency (ex. Utility bill or signed copy of lease). Students entering grades seven and eight will not be enrolled without an updated rubella immunization.

Tri-city mayors seek proposals to operate warming center for winter season

The City of Rochester released a bid this week from the mayors of Dover, Somersworth and Rochester that seek proposals from organizations to operate the warming center on Willand

Drive in Somersworth for the upcoming season.

The bid follows an agreement by the city councils of Rochester, Somersworth and Dover to jointly operate the Dover-owned facility from November 2022 through March 2023.

The warming center would operate up to 60 beds on an as-needed basis for overnight protection when extreme winter weather is predicted to pose a significant threat to life safety for unsheltered residents. The bid seeks proposals from organizations that have experience working with vulnerable populations and coordinating with local medical, health and social service providers. The organization must also be able to staff the facility, train volunteers, and operate the program on a cost-reimbursement basis with a fiscal management system compliant with government accounting systems.

Bid proposals are due to the City of Rochester by 5 p.m. on Tuesday, Sept. 27, 2022. Full bid documents are available at https://www.rochesternh.gov/bids/bids/bids/bids-23-11-tricities-willand-road-warming-center-services.

Election officers needed in all wards

The following events are from a variety of historical records, sources and texts about the history of Dover.

For more on the history of Dover, visit the Dover Public Library, Locust Street, and the Woodman Museum on Central Avenue. The Public Library also maintains an online collection of historical information, <u>located here</u>.

- **Aug. 28, 1797** Town selectmen vote to allow Dr. Jacob Kittredge to open a hospital to inoculate for the small pox. It was also decided that the selectmen, along with Dr. Ezra Green and William Hale, will constitute a committee to locate the hospital and decide when it should be opened and closed.
- **Aug. 29, 1814** The town appointed a committee, of which Daniel M. Durell was chair, to examine encroachments upon common land. The committee reported that many roads had been fenced in by adjoining landholders and much common land that formerly belonged to the town had also by some means become included in the lots of private individuals. The report was accepted, but no other action appears to have been taken upon it.
- **Aug. 29, 1842** The remains of two skeletons, thought to be those of Native Americans, were found while excavating the high bank that stood where Orchard Street meets Central Avenue, near which was also the site of Peter Coffin's garrison house in 1689.
- **Aug. 26, 1930** From the Associated Press: "A 40-foot whale attempted to break up a reunion of the Pollock family here today and got stranded at the wrong end of the Cochecho River. The obstreperous mammal chased the Pollocks up the river, 12 miles inland from Portsmouth, and got stuck in the mud. He flipped his tail in wild commotion, while the Pollocks gave him the piscatorial laugh. He was unable to go forward, reverse, or make a left or right turn. Police fired 14 bullets into his ebony hide while thousands of citizens looked on. The whale refused to die however and the board of health was informed of his visit. Just what the board is going to do with the four-ton wanderer was anybody's guess tonight."
- **Aug. 26, 1997** The Planning Board approved the 35,000-square-foot expansion of Cramer Fabrics Inc., located at Enterprise Park facility on Venture Drive. Cramer, an industrial fabric producer, began operations at the Venture Drive plant in 1994. The company was allowed to develop the upland parcel of land in exchange for agreeing to transfer developmental rights of wetlands areas they also own in the vicinity. As part of the agreement, Cramer set aside three

wetland areas which will remain permanently undeveloped. Cramer Fabrics continues to operate from its Dover facility on Venture Drive.

Admission is free, but donations are accepted.



Index Packaging expands their 150 Venture Drive location in Dover



The expansion, which added 58,000 square feet to the building, was the largest expansion in the 54-year history of Index Packaging Inc. The space will be used to augment the overall production capacity for the packaging company that has seen a 37% increase in sales over the past year. They now can fabricate foam and corrugated packaging products at their Dover location and have a warehouse large enough to support the production floor. The total size of the building is 105,000 square feet.

"We should be able to produce dramatically more specialty packaging, both in Dover and at our campus in Milton," says Mike Wiles, President at Index Packaging. "We are using the vacated floor space in Milton to add to our wood manufacturing capability.... we expect to be able to increase overall volume of both wood and foam/corrugated packaging by fifty percent, if all goes well."

Index Packaging has 70 employees in Dover and employs 210 overall. Many of them were onhand at the ribbon cutting ceremony as part of an employee appreciation day.

Index Packaging also purchased a company called Plastifoam on Oct. 1, 2021, which is based in Manchester and Merrimack. They are working on the consolidation of Plastifoam into one location (Merrimack) which will be completed by the end of September.



The Art Center presents 'Images of the Past: The Thom Hindle Collection'

In celebration of the upcoming 400th anniversary of the founding of Dover in 1623, The Art Center is pleased to present "Images of the Past: The Thom Hindle Collection". This insightful, historically significant exhibition is dedicated to the rich history of Dover, New Hampshire and the surrounding areas.

Thom Hindle, the curator of this collection has an avid interest in history and photography. He discovered early photographers work of the city that consisted of glass plate negatives,

photographers' notebooks, and antique cameras. In the last 50 years over 100,000 of these objects have been studiously preserved by Hindle and stored in a climate-controlled environment. This immense collection now includes not only images from Dover's past but also Rochester, Farmington, Concord and Massachusetts, as well as Maine, Vermont and New York

Throughout the month of September, The Art Center will feature photographs never exhibited before. Hindle reproduced these from original glass negatives representing the works of local and Boston area photographers. Focusing this exhibit on the years 1900 through the 1950s, Hindle chose to display a variety of themes. Vintage images of Dover, Rochester and Portsmouth are set along with exquisite "Portraits" including families, children. "Transportation" surges with images of street cars, trains, bicycles, motorcycles and even an old Jenny airplane at Hampton Beach. The 1939 World's Fair, Washington DC in the 1920s, fish shanties at Ogunquit, clam shacks at Joppa Flats and more are explored in "Travel". Early swimming costumes, the original Farragut Hotel in Rye and the Nubble Light and Bell Tower from the 1930s are all in the section "On The Beach". "Camping-Fishing" will be of particular interest to the outdoorsmen and women who want to see how old-fashioned camps were set up and what gear was used by both fishermen and hunters back in the day.

Hindle is also a noted author. "Dover a Century of Change" was published in 1994, "Tri-City Memories" published 2014, "Factory on Fire" published in 2017 and "Dover, N.H. Through Time" which was published in 2020.
