

## School Board subcommittee recommends renaming Horne Street school in honor of beloved nurse Fran Hopkins

A School Board subcommittee is recommending the full School Board name the Horne Street Elementary School after the beloved, retired school nurse Frances "Fran" Hopkins, who died last year due to complications from COVID-19.

The subcommittee, which includes School Board members Kathleen Morrison, Carolyn Mebert and Zachary Koehler, voted unanimously to recommend the change at the meeting Thursday, Aug. 5. Koehler said the School Board would vote on the



recommendation at its meeting Monday, Aug. 9. The subcommittee did not recommend a specific name but suggested the Fran Hopkins Elementary School at Horne Street as a potential candidate. Many residents sent emails and spoke in favor of the renaming proposal, sharing stories of how the Horne Street nurse, who retired in 2016, made a difference in their or their children's lives.

Tuesday, Thursday, Saturday: 8:30 a.m. to 3:30 p.m. The subcommittee was formed by Chair Amanda Russell during School Board Matters of Interest at the June 14, 2021, School Board meeting "to gather input and the appropriateness of the request and to formulate a recommendation." Russell noted she had received an email from resident David Bamford to rename the school.

Bamford, a friend of Hopkins, had made a similar name change request at the July 13, 2020, School Board meeting. At the time, the School Board declined to take action as it had no formal policy in place. Instead, the board formed a subcommittee with Morrison, Mebert and Koehler to study the issue and draft a policy.

At its Oct. 5, 2020 meeting, the School Board adopted policy "AED-A Recognition by School Building Renaming." The policy states that it has been the tradition in Dover to name schools for the areas they serve. The elementary schools are named for the neighborhood, and the middle and high schools are named for the entire community.

"In 2020, events have called this tradition into question and pressed for the need to establish a policy that would investigate, study, and recommend to the School Board the naming/renaming of a building or part of a building for an individual or individuals who have made substantial contributions to the District," the policy states.

The policy sets criteria to determine whether to proceed with a renaming, which includes the person the building is named after must be deceased for at least one year and have made "a major contribution to the district." The contribution may be finically and/or enhancement of student learning, instruction and/or support of children and families "over and above what as required by a job within the district."

The policy also states that all costs associated with remaining a building shall not be paid the district's operating budget and that the community name remain part of the official school name, such as "The Hilton Brothers Elementary School at Horne Street."

The School Board is scheduled to meet Monday, Aug. 9 at 7 p.m. in Room 306 of the McConnell Center.

## City Council to vote on \$8.2 million River Street Pump Station upgrades, new skatepark

The Dover City Council will meet Wednesday, Aug. 11 at 7 p.m. for its first regular meeting of the month.

The Council will consider approving appropriations to upgrade the River Street Pump Station and design and build the first phase of a new skatepark in Guppey Park. 
The River Street Pump Station upgrades are estimated to cost \$8,206,000. The resolution before the City Council would authorize a fiscal year 2022 Capital Improvements Program (CIP) appropriation and allow participation in the Department of Environmental Services Clean Water State Revolving Fund (CWSRF) for the pump station upgrades. The resolution authorizes \$7,206,000 for the FY 2022 CIP appropriations. These funds are in addition to the \$1 million appropriated in the FY 2020 CIP.

The cost first phase of the skatepark, which includes detailed plans and construction, is estimated to cost \$499,995.

Also on the agenda for the Council's consideration:

- Authorizing the expenditure to add two columbariums at Pine Hill Cemetery;
- Amending the City of Dover's merit, classification and pay plans;
- Updating the City of Dover welfare guidelines, which have not been revised since 2014;
- Approving a lease agreement with Collins Sports Center, Inc. for a storefront space at Dover Ice Arena.

## Health officials continue to urge people to get COVID-19 vaccinations as Delta variant surges

New data show Delta is different than past versions of the virus; it is much more contagious. While rare, some vaccinated people can get Delta in a breakthrough infection and may be contagious.


Fully vaccinated people: to maximize protection from the Delta variant and prevent possibly spreading it to others, wear a mask indoors in public if you are in an area of substantial or high transmission.

Unvaccinated people: get vaccinated and wear a mask until you do.

COVID-19 vaccines help protect people from serious illness, hospitalization, and death. Unvaccinated individuals account for nearly all the hospitalizations and deaths in the country.

## Mobile Vaccine Van will be in Dover on Sunday, Aug. 22

The NH Department of Health and Human Services Mobile Vaccine Van will be in Dover on Sunday, Aug. 22, from noon to 4 p.m., at the First Parish Church parking lot, 218 Central Avenue. All three FDA authorized vaccines will be available (Pfizer, Moderna and Johnson & Johnson). No appointment necessary!

Vaccines administered at the van are free and available to anyone 12 and older. Parental consent is required for children ages 12-17.



The NH Mobile Vaccine Van is available to businesses, religious organizations, community groups, fairs, festivals, and farmers markets. Anywhere people gather, you can request the van to provide #COVID-19 vaccines at no cost. The van is available through September 30.

#### Unable to make it to the clinic?

Vaccines are available at most local pharmacies including Rite Aid, Walgreens, Hannaford, Walmart, and CVS. To schedule an appointment, visit <u>vaccines.nh.gov</u> and click on "Find COVID-19 Vaccines". The link will bring you to the national site where you can search for

vaccines by zip code and vaccine type. Select the pharmacy nearest you to schedule an appointment. Some, but not all, pharmacies allow walk-ins so it's best to check before leaving your home.

## Financial assistance for housing, broadband available to those affected by COVID-19

There are numerous financial assistance COVID-19 programs that can assist renters, landlords and broadband internet users. There are also pending programs to help homeowners with mortgage payments. Below is a summary provided by the Office of Economic Development of available and soon to be available financial assistance programs.

#### **Emergency Rental Assistance**

There is federal rental assistance available to New Hampshire renters. The New Hampshire Emergency Rental Assistance Program (NHERAP) was launched in March 2021 using federal funds provided by COVID-19 relief legislation. NHERAP is managed by the New Hampshire Housing Finance Authority (NHHFA), and the applications are administered through the five regional Community Action Partnership agencies, including the Community Action Partnership of Strafford County.

### **Mortgage Assistance**

The federal American Rescue Plan Act of 2021 includes \$9.96 billion in federal funding for the Homeowner Assistance Fund, a program managed by the Department of the Treasury. The Department of the Treasury will allocate funds to states that can be used to provide direct mortgage assistance to homeowners. New Hampshire is eligible for up to \$50 million in federal mortgage assistance funds. The Governor's Office For Emergency Relief and Recovery (GOFERR) has used some of this funding to launch a foreclosure prevention pilot program and provide mortgage assistance to homeowners. Homeowners should direct their inquires about the program to 211 NH by dialing 211 or 866-444-4211.

#### **Landlord Incentive Programs**

New Hampshire Housing Finance Authority offers two new landlord incentive programs to encourage landlords and property owners to rent to tenants participating in two housing programs: the Emergency Housing Voucher Program and the Foster Youth to Independence Program. Landlords who lease to a qualified tenant may receive up to \$1,000. More information can be found <a href="https://example.com/here">here</a>.

#### **Emergency Broadband Benefit**

The Emergency Broadband Benefit is a Federal Communications Commission (FCC) program to help families and households struggling to afford internet service during the COVID-19 pandemic. This new benefit will connect eligible households to jobs, critical healthcare services, virtual classrooms and more. The Emergency Broadband Benefit will provide a discount of up to \$50 per month towards broadband service for eligible households and up to \$75 per month for households on qualifying tribal lands. Eligible households can also receive a one-time discount of up to \$100 from purchasing a laptop, desktop computer or tablet from participating providers if they contribute more than \$10 and less than \$50 toward the purchase price.

A household is eligible if a household member:

- Participates in specific assistance programs, such as SNAP, Medicaid, or Lifeline;
- Receives benefits under the free and reduced-price school lunch program or the school breakfast program, or did so in the 2019-2020 school year;

- Received a Pell Grant during the current award year;
- Experienced a substantial loss of income due to job loss or furlough since Feb. 29, 2020:
- Meets the eligibility criteria for a participating broadband provider's existing low-income or COVID-19 program; or
- If the household has an income that is at or below 135 percent of the <u>federal poverty</u> guidelines.

## City of Dover offers local business assistance program for coronavirus impacts

"Dover CARES" grant funding targeted to microenterprise and small businesses is still available. The grants are made possible by the Coronavirus Aid, Relief, and Economic Security (CARES) Act



and the Community Development Block Grant (CDBG) Program administered by the Department of Housing and Urban Development (HUD).

The grants are intended to provide working capital to assist small local businesses in avoiding job loss caused by the coronavirus. The program offers up to \$3,000 in assistance to qualifying businesses operating within Dover.

Funds from Dover CARES may either be used in two ways:

- To reimburse incurred business expenses to plan, prepare and respond to the coronavirus; or
- Offset a business disruption that occurred because of the coronavirus.

There are two types of Dover CARES available: **Microenterprise Business Assistance Grant** and **Small Business Assistance Grant**.

The **Microenterprise Business Assistance Grant** is available to sole proprietorships and small for-profit-businesses with five or fewer employees, including the owner(s) of the company. To be eligible, businesses must:

- Comply with certain HUD requirements, including household income thresholds for the owner(s) of the business and retaining the same number of positions for 90 days, beginning with the formal notice of approval.
- Have been in existence and continually operated in Dover since Nov. 1, 2020.
- Generate a minimum of \$60,000 in annual gross sales and is the primary source of income for the principal owner(s).
- Be current on federal, state and local taxes, and applicable health, safety and occupancy permits.
- Comply with all other grant eligibility requirements.

The **Small Business Assistance Grant** is open to small for-profit businesses with 2-15 employees, including any owner(s) of the company. To be eligible for this grant, businesses must:

- Comply with certain HUD requirements, including retaining the same number of positions for 90 days, beginning with the formal notice of approval.
- Have been in existence and continually operated in Dover since Nov. 1, 2020.
- Generate a minimum of \$60,000 in annual gross sales and is the primary source of income for the principal owner(s).
- Be current on federal, state and local taxes, and applicable health, safety and occupancy permits.
- Demonstrate that wages/benefits meet specific HUD income guidelines for either one full-time position of at least 40 hours a week or two part-time positions of at least 20 hours a week each.
- Comply with all other grant eligibility requirements.

Grants are open on a first-come, first-serve basis for completed applications. Incomplete applications will not be considered nor be used as a placeholder for a completed application. Once an application is determined to be complete, the Dover CARES Loan Committee will review the application. The Loan Committee is comprised of City of Dover officials, including City Manager J. Michael Joyal, Jr., Assistant City Manager Christopher G. Parker, and Finance Director Daniel Lynch.

The review consists of:

- Analysis of application and supporting material.
- Verification that the proposal meets all eligibility requirements.

## Candidate filing for Municipal Election opens Sept. 8

The filing period for the City of Dover municipal election begins on Wednesday, Sept. 8, 2021, at 8:30 a.m. and ends Friday, Sept. 17, 2021, at 4 p.m.

Candidates seeking the office of Mayor, City Council, School Board, Supervisor of the Checklist, Moderator, Selectpersons and Ward Clerk must file a written declaration of candidacy with the City Clerk during the filing period.

The municipal election is Tuesday, Nov. 2.

At the election, voters from all wards will elect the Mayor, two at-large City Councilors, and one at-large School Board member. In addition, voters in each of the six Dover wards will elect a City Councilor and School Board member and election officers, including a Supervisor of the Checklist, Moderator, three Selectpersons, and a Ward Clerk. All elected positions are two-year terms.



Candidates seeking an elected position must be duly qualified voters in the city. For Mayor and City Council positions, candidates must have lived in Dover for at least one year preceding the election. Candidates seeking a specific ward position must live in that ward. ## Former Mayor George Maglaras to discuss Dover's Waterfront History at next Dover400 lecture

Dover400, a committee of residents organizing Dover's 400th Anniversary, continues its virtual lecture series on Tuesday, Aug. 10, 2021, at 7 p.m. with an online presentation about Dover illustrious history as a 19th-century shipping port.

Our speaker for this webinar is George Maglaras, proprietor of George's Marina which is located at the former epicenter of Dover's thriving and bustling seaport. This shipping trade, which included all manner of vessels from gundalows to three-masted schooners, also supported many businesses and industries which lined the Cochecho River. This area, along Cochecho Street, was the commercial center of Dover for 200 years, until the great flood of 1896, called "Dover's Black Day", wiped out most riverfront businesses and deposited vast amounts of silt and sand into the river, essentially ending large-scale shipping.

George Maglaras grew up along the waterfront and is a highly regarded raconteur of Dover's maritime history. Maglaras has been a Strafford County Commissioner for 19 terms, and Chairman since 1987. He has over 45 years of involvement in numerous civic, municipal, and state organizations as well, serving in the NH Legislature and as Mayor of Dover in 1990-91. His presentation will combine the waterfront history with a large dose of entertainment through George's tales of river lore and legend.



The following events are recorded in "Notable Events in the History of Dover, New Hampshire: From the First Settlement in 1623 to 1865," by George Wadleigh, and several other historical sources.

For more on the history of Dover, settled in 1623 and the oldest European permanent settlement in New Hampshire and seventh oldest in the country, visit the Dover Public Library, Locust Street; and the Woodman Museum, Central Avenue. The Public Library also maintains an online collection of historical information, <u>located here</u>.

- **Aug. 10, 1706** Nicholas Peaslee was slain by the Indians in the daytime, at his cave, some miles above Oyster River, where he had dwelt night and day, summer and winter, from the last breaking out of the war, precisely three years. He was a man of strange confidence, and would not be persuaded to leave his place.
- **Aug. 7, 1826** "A very heavy thunder shower, during which the house of Moses Hodgdon, Esq. on Silver Street, was struck by lightning. A beautiful sycamore tree in front of the house received the electric fluid, an immense body of which ran down the trunk, ripping off the bark, a portion of the lightning entering the house by a limb of the tree. The house of Mr. John Evans, about 50 rods distant, was struck at the same instant: a man was struck to the floor, but recovered in a few minutes. About the same time, a barn belonging to Mr. Benjamin Kielle, about 2 1/2 miles from the village, was struck and considerably injured."
- **Aug. 11, 1826** Great rains and freshets, carrying away dams, bridges, etc., and doing much damage to crops. In a period of 35 days, from Aug. 11 to Sept. 14, rain fell on 17 days. "A damp mold and rust are penetrating every part of our dwellings. The hay in our barns, the vegetables in our gardens, and the potatoes in our fields are perishing with rot." (N. H. Republican)
- **Aug. 8, 1828** "Dover Society for the Promotion of Temperance" formed, the members pledging themselves to abstain entirely from the use of ardent spirits, except for medicinal purposes, the first society of the kind in Dover.
- **Aug. 12, 1844** Andrew Howard is tried for the murder of Phebe Hanson but the jury is deadlocked and he is sent back to prison.

Dover's thriving and bustling seaport included all manner of vessels from gundalows to 3-masted schooners, also supported many businesses and industries which lined the Cochecho River. This area, along Cochecho Street, was the commercial center of Dover for 200 years, until the great flood of 1896, called "Dover's Black Day", wiped out most riverfront businesses and deposited vast amounts of silt and sand into the river, essentially ending large-scale shipping. Registration required.

### 'Emergency need' need for donors

The American Red Cross has an emergency need for lifesaving blood amid the ongoing severe blood shortage and urges the public to make an appointment to give now at <a href="https://redcrossblood.org">https://redcrossblood.org</a>.

According to a press release, the Red Cross needs to collect more than 1,000 additional blood donations each day to meet the current hospital demand and end the severe blood shortage. Donors of all blood types are needed, especially type O, which the Red Cross says is only a one-day supply right now.

As an incentive and a thank you, the Red Cross will enter all who come to give blood between Aug. 1-15, 2021, a chance to win a VIP trip for two to the 2021 Bonnaroo Music & Arts Festival in Manchester, Tennessee, to be held Sept. 1-5. Those who come to donate throughout August will also receive a free four-month subscription offer to Apple Music by email (new subscribers only). Schedule a blood donation appointment through the <u>Red Cross Blood Donor App</u>, visiting <a href="https://redcrossblood.org">https://redcrossblood.org</a>, calling 1-800-RED CROSS (1-800-733-2767) or enabling the Blood Donor Skill on any Alexa Echo device. Red Cross requests donors to schedule an appointment instead of dropping in.

The Red Cross tests blood, platelet and plasma donations for COVID-19 antibodies, provided to the donor when results are available. The test may indicate if the donor's immune system has produced antibodies to this coronavirus, regardless of whether an individual developed COVID-19 symptoms. Testing may also identify the presence of antibodies developed after receiving a COVID-19 vaccine. In most cases, those who have received a COVID-19 vaccine can donate. However, knowing the name of the vaccine manufacturer they received is vital in determining donation eligibility.

## A guide to solid waste and curbside recycling

### Don't let your recycling be rejected

Is your trash or recycling not getting picked up? It may be because it does not conform to the City of Dover's recycling and solid waste rules.

Dover's Community Services Director John Storer requests that curbside customers ensure the items placed in recycling containers are recyclable consistent with local guidelines and that bulky items are correctly tagged.



#### What's acceptable for curbside recycling in Dover?

- **Plastic**: #1, #2 and #5, provided the items are bottles, tubs and jugs. Rinse and dry. Bottle caps can be recycled if removed, washed, and placed back on the bottle. Loose caps, which fall through processing screens, cannot be recycled.
- Glass: only bottles and jars. Rinse and dry.
- Cardboard, cartons and paper: Newspaper, magazines, office paper and junk mail only. Flatten all boxes, then place them into recycling bins, paper bags, or bundle and tie. When flattened, cardboard dimensions must not exceed two feet by two feet. Pizza boxes with grease must be thrown away as the oil contaminates the other recyclables.
- No styrofoam is accepted, even with a recycling symbol on the packing.
- No plastic bags are accepted.

Plastics that are not accepted include plastic bags, plastic utensils, straws, plastic wrap, tarps and colored cups. Recycling bins that contain non-recyclable items may not be picked up or flagged with a warning sticker. See full details of <u>Waste Management's curbside pickup here</u>.

Nationwide, Waste Management estimates that 25 percent of items placed in recycling bins are actually trash. This 25 percent of trash can contaminate the good recycling commingled with it.

"Recycling contamination happens when trash ruins otherwise good recyclables," says Waste Management in their Recycling 101 webpage.

For example, food or liquid placed recycling that saturates paper and cardboard can contaminate it. "Once contaminated, these recyclables can no longer be recycled. They become trash."

For large, non-metal trash items, such as beds, couches, toilets, sinks, carpets, and furniture, residents must purchase a "Bulky Item Tag" for each bulky trash item to be picked up. A bulky item tag costs \$10 and is available at most places where Dover trash bags can be purchased. See the Community Services' Bag and Tag webpage for a list of locations.

Please note, televisions, computer monitors, microwaves and other metal objects are not accepted for bulky item pickup.

Items left on the curb without a tag may be turned over to the City's health officer to see whether the items can be traced to a property.

All recycling and trash, including bulky tag items, should still be placed curbside by 7 a.m. on the designated collection day or as early as 4 p.m. the day before.
