## **Community Power saves Dover customers more than \$2 million since launch**

### **New rates set for February remain below Eversource default rate**

Dover Community Power announced that its default "Granite Basic" electricity supply rate will be set at 8.9 cents per kilowatt-hour from Feb. 1, 2025, through July 31, providing continued savings for Dover residents compared to Eversource's rate of 8.929 cents per kilowatt-hour for the same period.

Thanks to the forward-thinking decision by Dover's City Council and Mayor to establish the Dover Community Power program, Dover residents and businesses have saved more than \$2 million in electricity costs since the program's launch in October 2023, providing a significant boost to the local economy.

"Through Oct. 31, 2024, Dover Community Power has saved customers \$2,053,000 in total since launching at the end of October 2023," said Jackson Kaspari of the Community Power Coalition of New Hampshire (CPCNH). "This corresponds with supplying 91,500 megawatt-hours of energy during this period."

Kaspari noted that CPCNH's impact extends beyond direct savings: "CPCNH has led to increased competition which has driven down both the price and decreased the spread between utility rates across the various territories which is helpful to all customers within New Hampshire."

Dover customers can choose from four power supply options:

- Granite Basic (Default): 8.9¢/kWh, 25.2% renewable energy
- Granite Plus: 9.6¢/kWh, 33% renewable energy
- Clean 50: 10.3¢/kWh, 50% renewable energy
- Clean 100: 12.3¢/kWh, 100% renewable energy

By selecting higher renewable energy options, Dover customers have contributed to reducing greenhouse gas emissions and supporting the community's efforts to combat climate change and its devastating effects. For an average household using 650 kilowatt-hours (kWh) per month, the default Granite Basic rate would result in approximately \$58 per month in supply charges.

New Hampshire municipalities and counties founded CPCNH as a transparent and locally accountable public power agency. The organization works toward directly contracting with renewable generators, offering new rates and project solicitations, and advocating for regulatory reforms to protect the competitive market and enable innovation.

Martin Luther King Jr. Day is a parking holiday in Dover. Metered parking is free on parking holidays, except for the Orchard Street Parking Garage and Transportation Center Parking Lot, which are paid parking at all times.



## City Council honors DHS Marching Band for 17th consecutive gold medal

The Dover City Council recognized the Dover High School Green Wave Marching Band and Color Guard Wednesday night, Jan. 15, 2025, for earning their 17th consecutive Gold Medal at the Maine Marching Band Finals in October 2024.

Mayor Robert Carrier presented a proclamation celebrating the band's achievement at the competition at Sanford High School, where they performed a Western-themed show titled "Wanted."

"The Green Wave Marching Band and Color Guard have demonstrated extraordinary dedication, skill, and musical excellence throughout the 2024 fall season," the mayor said, reading from the proclamation.

The award-winning performance featured soloists Sam Gorman on saxophone, Sofia Gonzalez-Ramirez on trumpet, and Sam Harmoko and Tyler Mercieri on snare drum. Drum Majors Emma Burton and Kaela Robins led the band, while Kaitlyn Yake and Olivia Champagne served as Color Guard captains.

The proclamation, signed by Carrier, celebrates "the continued legacy of musical excellence demonstrated by this extraordinary group of student musicians."

## Council proclamation recognizes Dover High School Cheerleading Team

The Dover City Council recognized the Dover High School cheerleading team Wednesday for capturing the Division 1 Fall Spirit State Championship, marking the first state title for many team members.

"The DHS Cheerleading Team culminated their season by earning the prestigious title of Division 1 Fall Spirit State Champions with an outstanding score of 102.1, triumphing over 17 Division 1 teams, including Pinkerton Academy, whom they outscored by 6 points," the mayor said, reading from the proclamation.

The 12-member squad overcame early-season challenges to achieve their championship victory. The team opened their competitive season with a win, followed by a second-place finish, before securing the state title.

The proclamation highlighted the team's dedication to perfecting new and difficult stunting elements never before attempted by Dover High cheerleaders.

"This team exemplified unwavering drive, passion, and resilience, overcoming adversity with relentless effort and enduring countless repetitions of their routine to perfect every element, proving their commitment to excellence," the mayor said.

## Application for property tax credits and exemptions open through April 15

The City of Dover offers property tax exemptions/credits for qualified property owners that include veterans, the elderly, the blind, the deaf, the disabled, and those with solar energy systems. The deadline to apply for the exemptions and credits for the December 2025 property tax bill is Tuesday, April 15, 2025.

### Veterans tax credits

The City of Dover offers credits for qualified veterans, their spouses, or surviving spouses, including:

- Veterans' Credit provides up to \$750 annually for those who served on active service in a qualifying war/conflict with applicable awards. This credit also encompasses service members who have served on active service in a qualifying war/conflict and remain on active duty. It also includes training for active duty by a National Guard or Reserve member.
- All Veterans' Credit provides up to \$750 per year for those who served or are currently serving and are not eligible for the Veterans' Credit. This also includes training for active duty by a member of the National Guard or Reserve.
- Service-Connected Total and Permanent Disability Credit, providing up to \$4,000 annually to veterans totally and permanently disabled due to a service-connected disability; double amputees or paraplegics due to service-connected injuries also qualify.

Refer to state laws RSA 72:28, RSA 72:28-b, and RSA 21:50 for specifics regarding eligibility for these credits. Veterans and active service members are encouraged to contact the Tax Assessment Office at 603-516-6014 with questions about veteran tax credits and/or eligibility.

### Elderly exemptions

The property tax exemptions for the elderly who meet the age, income, asset, and residency requirements:

- For ages 65-74: \$206,000
- For ages 75-79: \$291,000
- For ages 80 and older: \$373,000.

### Blind Exemption

The property tax exemption for those legally blind is \$206,000. Applicants must meet ownership and residency requirements.

### Deaf Exemption

The property tax exemption for those who are deaf or have a severe hearing impairment is \$206,000. Applicants must meet residency, income, and asset requirements.

### **Disability Exemption**

The property tax exemption for those eligible under Title II or Title XVI of the federal Social Security Act for benefits to the disabled is \$206,000. Must meet residency, income, and asset requirements.

### **Solar Energy Systems**

Provides up to \$30,000 off the property's assessed value of a solar energy system. As defined by RSA 72:61, a solar energy system utilizes energy to heat or cool the interior of a building or to heat water for use in a building that includes one or more collectors and a storage container. It also means a system that provides electricity for a building using photovoltaic panels. The amount of the exemption is the assessed value of the solar energy system, up to \$30,000.

## Angle Street water main, stormwater drain replacement begins this month

The City of Dover will replace the water main and stormwater drain on Angle Street later this month. The project is slated to start on Monday, Jan. 27 and continue through mid-March.

Angle Street will be closed to through traffic during project work hours, Monday-Friday from 7 a.m. to 5 p.m. Angle Street residents may experience delays getting their vehicles in and out of the driveway during this time. Crews will give residents advance warning when their driveway will be blocked for utility work.

Parking on the street will be prohibited at all times until the project is finished – including nights and weekends. Other parking restrictions may be posted nearby if necessary.

At the beginning of the project, there will be a water shutoff affecting Angle and Academy street residents so workers can install a shutoff valve on the water main. This will allow crews to install the new main without affecting water service. Once the new main is installed, there will be brief water shutoffs to connect properties to it. City staff will provide at least 24-hour notice before the shutoffs occur.

The Angle Street closure is not anticipated to directly impact dropping off or picking up students at Saint Mary's Academy.





## Have you ever visited Garrison Hill Tower?



The following events are from various historical records, sources, and texts about the history of Dover.

For more on the history of Dover, visit the Dover Public Library, Locust Street, and the Woodman Museum on Central Avenue. The Public Library also maintains an online collection of historical information [located here](#).

**Jan. 22, 1770** — The town voted to construct a new bridge over the Cochecho River near the upper dam, just below Capt. Waldron's mills at the lower falls. To fund the project, 200 pounds were raised through taxes, and workers were to be paid two shillings per day for their labor, with the understanding that they would provide their own tools and supplies. On Feb. 26, another meeting was held to decide whether to reconsider the earlier decision. After a formal vote, the town chose not to overturn the original plan, confirming their commitment to building the bridge.

**Jan. 23, 1777** — Strafford County Sheriff Theophilus Dame received instructions from the Committee of Safety regarding prisoners from New York. He was directed to release from prison those individuals who provided bonds, along with two reliable guarantors who were residents of the state. These guarantors pledged to ensure the prisoners would remain confined within the town of Dover. The policy aimed to manage the prisoners' movements while maintaining security and accountability within the community.


**Jan. 18, 1855** — The region experienced the tremors of an earthquake on this day. Reports of the shock were widespread, with many residents feeling the ground shake. Although the earthquake caused alarm, there were no records of significant damage or injuries.

**Jan. 17, 1977** — More than 1,000 Dover residents returned to their homes after being

evacuated the day before following the early-morning derailment of a Boston and Maine freight car carrying liquid propane gas. The tank car was carrying 33,000 gallons of liquid propane when it left the tracks and slid down an embankment, landing next to the Cochecho River in the city's downtown. Firefighters from Dover and neighboring communities remained on scene in the frigid cold while specialized crews from Boston used two large railroad cranes to move the rail car back up the hill and onto the track.

**Jan. 17, 1997** — After a warm start to the winter, temperatures on this day dropped to 30 below zero in Dover as strong winds sent the wind chill spiraling down.

## **Serial killer expert to speak at virtual event**

Forensic psychologist Katherine Ramsland will discuss her extensive work with notorious serial killers in a virtual presentation at Dover Public Library on Monday, Jan. 27, at 7 p.m.

Ramsland's talk, "Encounters with Killers," will explore her interactions with multiple convicted murderers, including Dennis Rader, known as BTK. She will share how these experiences shaped her career in forensic psychology and writing.

The former DeSales University assistant provost has authored 73 books and more than 1,800 articles on criminal psychology. Her works include "Confession of a Serial Killer: The Untold Story of Dennis Rader" and "How to Catch a Killer." She serves as executive producer of "Murder House Flip" and has consulted for television shows including "CSI," "Bones" and "The Alienist."

## Do you know how to recognize warning signs of suicide?

The Dover Mental Health Alliance and Dover High School are partnering with NAMI New Hampshire to offer free "Gatekeeper" suicide prevention training in February and May.

DMHA works with authorized NAMI NH Connect trainers to deliver the three-hour curriculum to school groups, organizations, businesses, and community members 18 and older throughout Strafford County. The program offers an integrated community approach to reduce suicide among youth ages 10-24 and adults.

Participants learn to identify warning signs and connect individuals with appropriate resources.

- Thursday, May 8, 5-8 p.m., Dover High School library

"Our region is fortunate to have these organizations working together to provide mental health and suicide prevention education," said DMHA Co-founder Suzanne Weete. "It takes all members of a community to be engaged to end stigma and prevent suicide. These training opportunities are an invitation for community members to be part of the solution."

Trainers include community members, parents, first responders, teachers, administrators, prevention coordinators and case managers. The training is designed for anyone wanting to learn about suicide risk factors and warning signs. Coaches, teachers, faith leaders, business people, first responders, parents and young adults are encouraged to participate.

## Sign up for winter parking ban alerts

The City of Dover utilizes winter parking bans as needed through the winter season to clear the streets of snow. The public may sign up for phone, text and/or email to receive parking ban alerts.

Parking bans can occur during a storm or afterward for cleanup. When a parking ban is in effect, all vehicles must be off public ways and specific parking lots to avoid being ticketed and towed.

To receive text or phone alerts, visit <https://bit.ly/dovercodered> or text "DoverNH" to 99411 from your phone. Follow the instructions to create a managed account to modify notification settings.

To receive email alerts, visit <https://bit.ly/doverdownload> and add "Parking Ban Alerts" to your email subscriptions.

The City of Dover also utilizes its website, social media accounts, Channel 22, and press releases to local news media to notify residents about parking bans.
