# Dover's Master Plan topic of Feb. 5 Council workshop

The City Council will receive an update on the city's <u>Master</u> <u>Plan</u> at a Wednesday, Feb. 5 workshop. The workshop will include an overview of the Master Plan's purpose, its role in guiding long-term growth and development, and how it informs city policies and decision-making.

Recently, the Planning Board adopted the Master Plan's Open Space and Conservation Chapter update, and work is underway now to update the Land Use Analysis Chapter, with the chapter's steering committee <u>holding its first meeting</u> last week. The workshop will also include an executive summary of the Master Plan and show completed action items to date and ongoing recommendations from all chapters of the plan.

# Council to hold special session on Ethics Commission report, recommendations on ethics complaint

The City Council will hold a special session on Wednesday, Feb. 19 at 7 p.m. to receive the Ethics Commission report on its findings and recommendations regarding Caitlin Wilkie's ethics complaint against Councilor Fergus Cullen.

The City Council at its Jan. 29 meeting voted to accept the report from the Ethics Commission, which is included in the Jan. 29 City Council agenda materials, and refer the report to a public meeting on Feb. 19. Included in the Jan. 29 meeting minutes is correspondence from Cullen. Both are available online within the Jan. 29 City Council meeting folder.

Wilkie, of Sixth Street, filed a complaint with the City Clerk's office on Nov. 26, 2024 alleging Fergus Cullen, Ward 6 City Councilor and the Council's Planning Board designee, had conflicts of interest defined by Article 10 "Conduct of Officials" of the Dover City Charter and Chapter 21 "Code of Ethics" of the City Code. The complaint cites Charter Article 10-2 "Conflicts of Interest and Disqualification from Decision-Making Process," and code sections Chapter 21-2 "Conflicts of interest," Chapter 21-5 "Required disclosure by officers and employees; recusal," and Chapter 21-8 "Investments in conflict with official duties."

The Ethics Commission held a hearing on Jan. 2 and continued deliberation on Jan. 15.

<u>Chapter 21</u> of Dover's ordinances defines the city's ethical standards, the role of the Ethics Commission, complaint procedures, and the City Council's remedies. The Ethics Commission serves in an advisory role to the City Council.

# Library reopens at McConnell Center on Monday, Feb. 3

The Dover Public Library will reopen in its temporary location on Monday, Feb. 3 at 9 a.m.

Its operating hours will now match the McConnell Center's hours: Monday through Thursday, from 9 a.m. to 8:30 p.m. Friday, from 9 a.m. to 5 p.m., Saturday, from 9 a.m. to 4 p.m. and Sunday, from 12 to 4 p.m. The library's phone numbers remain the same; contact the Circulation Desk at 603-516-6050 or the Children's Room at 603-516-6052 starting Feb. 3.

Adult services will be located in the cafeteria, and Children's services will be in Room 305. Library events will occur in Room 306.

Public use of computers will continue in the McConnell Center. The Dover Adult Learning's computer lab in McConnell Center's Room 301 will be open for public use on Mondays, from 9 a.m. to 5 p.m., and Thursdays and Fridays, from 1 to 5 p.m. To schedule technology help during these times, contact Technology Librarian Nick Gagnon at <u>n.gagnon@dover.nh.gov</u>. There will also be computer stations in the McConnell Center cafeteria after the Feb. 3 opening during regular hours.

The library's physical space at 73 Locust St., closed to the public on Jan. 13, which will remain in place for about a year to allow renovations at the library. The renovations will enhance the 1905 Carnegie Library by adding accessible entrances and programming

space, including additional meeting rooms. The historic front façade of the building will remain unchanged, as will its detailed woodworking throughout. The new addition on the parking lot side of the library will create two entrances: One for the Children's section on the ground floor and another for the main library section on the first floor.

# City Council to receive FY26 proposed budget Feb. 12

City Manager J. Michael Joyal, Jr. will introduce his proposed fiscal year 2026 budget at the City Council meeting on Wednesday, Feb. 12.

The City Manager's budget will incorporate the School Board's recommended budget for the School Department, which the School Board approved on Jan. 6. The city-wide budget will also include the first-year projects in the latest six-year Capital Improvements Program adopted in December.

Once the budget is introduced, a digital version will be available on the <u>FY2026 Budget</u> <u>Revealed webpage</u>, which will also include video recordings of budget meetings and workshops and any accompanying documents. A physical copy of the budget will also be available for review at the Dover Public Library and the City Clerk's office. School Board budget documents and video recordings are already posted on the page.

The introduction of the budget begins two months of budget review by the City Council. In subsequent weeks, the City Council will hold workshops to review each department's budget. The Council will also hold two public hearings: one for the public education component of the budget, and one for all other city departments. The City Charter requires the City Council to adopt the annual budget by April 15.

During the budget season, City Manager Joyal will also release a weekly newsletter that recaps any budget-related presentations and a look ahead to what will occur the following week. # Citywide parking ban in effect tonight

Due to the forecast of snow beginning today, Friday, Jan. 31, 2025, a citywide parking ban will be in effect beginning tonight at 8 p.m., and concluding Saturday, Feb. 1 at 6 a.m. The ban will be in effect downtown on Saturday, Feb. 1, from 1 a.m. to 6 a.m. only.

While in effect, parking is banned on:

- City streets, sidewalks or adjacent public parking areas.
- Third Street and Belknap parking lots, and Orchard Street lot public parking spaces.

#### While in effect, limited parking is allowed on:

- The Fourth Street lot's outside spaces only.
- The two outermost rows of the Library lot, facing either the Greek Orthodox Church or Atkinson Street.
- The first two floors of the Orchard Street Parking Garage require paid parking at all times, at \$1.25 per hour. Use Flowbird pay-by-phone app to extend parking time remotely. The top three floors of the garage are reserved for permit parking only. If the parking garage is at capacity, the Transportation Center lot is the best option for off-street parking. The Transportation Center parking lot requires paid parking at all times.

In addition to snow removal, the parking ban allows Community Services crews to treat the roads with salt and sand, and keep areas open for safe travel.

According to the National Weather Service, Dover may receive 1 to 3 inches of snow beginning this afternoon.





The following events are from various historical records, sources, and texts about the history of Dover.


**Feb. 5, 1658** — It was agreed that 20 pounds per year should be raised for a schoolmaster for teaching all the children of the town. The schoolmaster would be responsible for teaching reading, writing, Latin and math.

Feb. 2, 1836 — The coldest day of the year is recorded at 17 degrees below zero.

**Feb. 3, 1844** — Mr. B. A. Ford passed with a horse and sleigh over the ice from Dover Neck to Newington, a circumstance which had not before occurred for 30 years. The winter of 1844 was so severe that Boston Harbor froze over, and a canal had to be cut to admit the passage of vessels.

**Feb. 1, 1889** — The schooner Zimri S. Wallingford, built by the Dover Navigation Company in 1882, arrived in Palatka, Florida. The Z.S. Wallingford was one of five schooners constructed by the Dover Navigation Company to accommodate the growing mercantile needs of Dover's mills. The Dover Navigation Company, despite a slow start, became a great commercial success. The schooners generated significant interest among the residents of Dover, who followed daily accounts of the schooners' location and payloads in the local newspapers. Jan. 31, 1915 — By this day, the Jas. F. Parle Ice Company had cut and stored over 6,000 tons of ice from the Bellamy River and was preparing to cut ice on the Cochecho River.

# Sign up for winter parking ban alerts

The City of Dover utilizes winter parking bans as needed through the winter season to

clear the streets of snow. The public may sign up for phone, text and/or email to receive parking ban alerts.

Parking bans can occur during a storm or afterward for cleanup. When a parking ban is in effect, all vehicles must be off public ways and specific parking lots to avoid being ticketed and towed.

To receive text or phone alerts, visit <u>https://bit.ly/dovercodered</u> or text "DoverNH" to 99411 from your phone. Follow the instructions to create a managed account to modify notification settings.

To receive email alerts, visit <u>https://bit.ly/doverdownload</u> and add "Parking Ban Alerts" to your email subscriptions.
